AGE LIMIT:-

The Candidates must have attained the age of 21 years and must not be above the age of 37 years on the date of advertisement.

Deptt. under the Central Plan Schemes, State Plan Schemes and externally aided Schemes duly concurred by Finance Deptt. prior to issue of the G.A Deptt. Notification No.32010/GEN dt.12.11.2013 and below the age of 45 years and have completed at least one year of continuous service shall be allowed to take part in the recruitment process as per the aforesaid notification of the G.A Deptt.

MODE OF SELECTION: -

1. The selection of candidates shall be made on career assessment as detailed below:

i) HSC (Excluding 4 th Optional)/equivalent	20%
ii) +2 Science (Excluding 4 th Optional)/ equivalent	30%
iii) D.M.R.T/D.M.L.T (as the case may be)	50%

Provided further that the candidates engaged on Contractual basis in similar assignment under Health & F.W. Deptt. under the Central Plan Schemes, State Plan Schemes and externally aided Schemes duly concurred by Finance Deptt. Prior to issue of the G.A Deptt. Notification No.32010/GEN dt.12.11.2013 and below the age of 45 years and have completed at least one year of continuous service shall be allowed one percent extra mark of the total marks for each completed year of continuous service subject to maximum of fifteen percent which will be added to the marks secured by them for deciding their merit position as per the aforesaid notification of the G.A Deptt.

2. There shall be no written test or interview. Selection shall be done as per para-11 & 12 of the card Rule issued vide Notification No.28237/H dt 10.11.2014 & No.28232/H dt.10.11.2014.
3. The panel list shall be valid for a period of one year or till completion of panel list which-ever is earlier.


Knowledge in Odia:
