Applications are invited from eligible candidates belonging to ST/SC Category in the prescribed format for engagement as Staff Nurse on contractual basis in M.K.C.G. Medical College Hospital, Berhampur against existing vacancies and vacancies likely to be occur in the service with in the year 2019 as detailed below:-

Reservation:

The reservation of vacancies for Physical Handicapped, Ex-serviceman & Women candidates of SC/ST category only shall be applicable as per Govt. Rules.

AGE LIMIT:-

The Candidates must have attained the age of 21 years and must not be above the age of 37 years on the date of advertisement. The upper age limit is however relaxed by 10 years in respect of candidates belonging to physically handicapped and in case of Ex-serviceman, sportsperson candidates as per prevailing rules. A person, who comes under more than one reserved category, shall be eligible for only one benefit of relaxation, which shall be considered most beneficial to her/him.

Provided further that, the Staff Nurses engaged on contractual basis under the Central Plan Schemes, State Plan Schemes and externally aided Schemes against the post created with the concurrence of the Finance Department, who are below the age of 45 years and have completed at least one year of continuous service as on the date of advertisement can apply for the post through their respective authorities.

Provided further that the ASHA Karmies working in the health system of the State who are below the age of 45 years and have completed at least one year of continuous services on the date of advertisement can apply for the post if they are having the minimum prescribed qualification.

SCALE OF PAY & NATURE OF ENGAGEMENT :-

I. The appointment to the posts shall be made initially on contractual basis on consolidated monthly remuneration of Rs. 10,000/-

II. The condition of service and the tenure of the contractual appointment to the posts will be regulated by the G.A. Deptt notification No.32010 dtd.12.11.2013 i.e Odisha Group "C" & Group "D" posts (Contractual appointment) Rules-2013 and the Odisha Nursing Service (Methods of recruitment and conditions of service) Rules-2015 notified vide No.14488 dtd.30.06.2015 of the Health & Family Welfare Deptt and instruction received from time to time from Govt.

Provided further that, the Staff Nurses engaged on contractual basis under the Central Plan Schemes, State Plan Schemes and externally aided Schemes against the post(s) created with the concurrence of Finance Department or engagement made through manpower service provider agencies with concurrence of Finance Department who are below the age of 45 years and have completed at least one year of continuous service on the date of advertisement shall be allowed one percent extra mark of the total marks for each completed year of continuous service subject to maximum of fifteen percent which will be added to the marks secured by them for deciding merit position.

Provided further that the ASHA Karmies working in the health system of the State who are below the age of 45 years and have completed at least one year of continuous services on the date of advertisement shall be allowed one percent extra mark of the total marks for each completed year of continuous service subject to maximum of fifteen percent which will be added to the marks secured by them for deciding merit position.

GENERAL CONDITIONS:-
