The detailed provisional valid & invalid list, scheduled for document verification for teaching & non teaching posts under ST & SC Development Department in Ganjam District in pursuance to this office Advertisement No-2492/SSD dated-28.08.2018 is published in District website i.e www.ganjam.nic.in. The candidates are informed to go through the said publication.

- Document verification of candidates for all the posts advertised as per the above advertisement will be conducted as per the table given below.
- No separate intimation shall be issued to individual candidates in this regard.
- The candidates who fail to attend the document verification will be summarily rejected.
- The computer proficiency test for 20 (Twenty) nos. of candidates for Jr. Clerk-Cum-Accountant will be held on 21.01.2019 afternoon in N.I.C, Collectorate, Ganjam. The **top 10** candidates (mark basis) from UR category & **top 10** candidates (mark basis) from ST category, who will be selected after document verification will attend the computer proficiency test.
- The candidates in valid list will submit the required documents as mentioned in the remarks column during document verification.
- The candidates can submit objections (if any) on or before 25.01.2019 by Speed Post or Regd. Post only addressed to District Welfare Officer, Ganjam, Chatrapur, PIN-761020, superscribing the name of the post applied for on the envelope.
- The selected PwD candidates will be referred to State Medical Board, Odisha.
- The mark sheets of valid candidates for the post of Peon in Biju Patnaik Adarsha Vidyalaya, Konisi will be referred to D.E.O, Ganjam, Berhampur for verification and counter signature of concerned BEO & DEO on the mark sheet issued by concerned school.
- After consideration of objections, one valid list will be prepared for the candidates belong to invalid list. They will be called for document verification on 04.02.2019 in this office. **The draft valid list will be hoisted in District website i.e www.ganjam.nic.in only and will not be advertised in any news paper.** Candidates following the said draft valid list will attend the document verification on 04.02.2019. If any one fails to attend the document verification on 04.02.2019 his candidature will be rejected.
