





The interested NGOs / Firms/ Organizations/ Individuals fulfilling the eligibility criteria may submit their Expression of Interest (EOI) along with all supportive documents to the **Project Director, DUDA Ganjam**, DRDA Campus Chatrapur **within 7 days** of the publication of this notice through Speed post/ Registered Post/Courier only and the same will be opened within Three days of last date of submission of EOI in the office of the PD, DUDA Ganjam in presence of the Committee & representatives of the NGOs / Firms/ Organizations/ Individuals. The sealed envelope containing the EOI must be super-scribed on the top of the Envelope as EOI for engagement of Plastic Waste collection with self-address, contact No., e-Mail etc. on the left side of the envelope. 

1. Scope Of Work :

- a. Provide training to plastic waste collectors of the ULBs of Ganjam District.
- b. Purchase the Dry and Segregated recyclable plastic waste collected from the ULBs for proper recycling on agreed rates of different types of plastic.
- c. Arrange for disposal of the plastic wastes collected by the ULBs at their respective HQR for co-processing and charge disposal charges.
- d. Conduct training and development programmes of Rag-pickers /SHGs for plastic waste managements.
- e. Organize plastic waste recycling awareness campaigns.

2. Deliverables:

- a. Maintain all the quality standards of the solid waste management Rules & plastic waste management Rules.
- b. Comply with all applicable local laws, ordinances, circulars, notifications, instructions in performing its obligations.
- c. Execute an MoU with the Collector-cum-Chairman with necessary term and conditions as provided in solid waste management Rules & plastic waste management Rules.

3. Eligibility Criteria:

- a. The NGOs/ Firms/ Organizations/ Individuals must have an office in the state of Odisha so that any technical issue raised will be addressed as soon as possible.
- b. The NGOs/ Firms/ Organizations/ Individuals must possess valid registrations for all statutory requirements such as PAN, GST etc.
- c. The NGOs/ Firms/ Organizations/ Individuals can also be a startup registered with DIPP/startup India.
- d. The NGOs/ Firms/ Organizations/ Individuals should not be blacklisted by any Government Entity as on date of submission of bid.
- e. The NGOs/ Firms/ Organizations/ Individuals should have a Bank account for a least three years preceding the date of filing of EOI. Copy of Bank passbook for the last three year should be enclosed.
- f. The bidder with prior experience with Ganjam Administration on the similar work will be preferred.
- g. Authority reserves the right to accept/ reject any/ all bid without assigning any reason thereof.

4. Bid Evaluation:

- a. The NGOs/ Firms/ Organizations/ Individuals to submit EOI in two parts: Part A-technical EOI (In Annexure- A) Part B-financial EOI (In Annexure- B) in two different envelops. Both enclosed in a single envelop clearly super-scribed with "EOI for engagement of Plastic Waste collection".
- b. The Financial Bid of successful qualifying Technical Bidder will be opened.
- c. DUDA Ganjam, will award the work in accordance with the decisions of the committee.
