Madam/Sir,

In inviting a reference to the subject cited above, I am to say that as per Notification No.7584/Gen., dtd:08-03-2019 of Govt. of Odisha in G.A & P.G Dept., a Draft Common Gradation List of Section Officers working in various District Level Offices have been prepared basing on the available information received from your Office.

In this context, the followings are submitted for your information:

- As this common gradation list is meant for ministerial staff working in District Level Offices, thus the Offices where the post of Jr.Asst./Sr.Asst./S.O belongs to "State Cadre", have not been taken into consideration and the name of those Section Officers have not been included in the draft common gradation list.
- Rule-7 of the above Notification of Govt. of Odisha in GA & PG Deptt. envisages that, "A Common gradation list of Section Officers/Establishment Officers of the District shall be prepared by the concerned Collector on the basis of select list prepared by the Odisha Sub-Ordinate Staff Selection Commission for appointment to the rank of Junior Assistant for the purpose of consideration of promotion to the rank of Establishment Officer/Senior Establishment Officer respectively.

Provided that in case of non-availability of relevant select list in old cases, the date of appointment to the service as Junior Assistant (Junior Clerk) shall be the factor for determination of inter-seniority for preparation of the common gradation list of Section Officers/Establishment Officers respectively."

As the draft common gradation list includes Section Officers of various District Level Offices and the common merit list including all the Section Officers is not available in this Office, thus the inter-seniority of the draft common gradation list is determined basing on the factor i.e. date of appointment/date of joining in the base level post of Jr.Asst. (Jr.Clerk).

(C)The copy of draft common gradation list of Section Officers as on 15-01-2020 is also uploaded in the Ganjam District website for verification and filing objection.

As desired by the Collector, Ganjam, I am to request you to please do the following needful action and report compliance latest by 20th June'2020:

- A copy of draft common gradation list of Section Officers as on 15-01-2020 working in various District Level Offices of Ganjam District is hereby enclosed herewith and it is requested to circulate the same among all the Section Officers working under your jurisdiction inviting objections, if any, within 15 (fifteen) days from the date of issue of this letter. The objections received from the employees should be forwarded to this Office after due verification of the same with reference to Service Book and other relevant records with specific views of concerned DDOs/District Level Officers.

Further if any of the employee belongs to any reserved category especially PwD & the same has not been incorporated against his/her name in the draft common gradation list, then the same may please be verified at your level w.r.t. relevant documents & make necessary entry in the 1st page of original Service Book. After that the proposal be submitted along with attested copy of 1st page of original Service Book as well as relevant documents for making entry in the final gradation list.

No objection received after 15 (fifteen) days and no proposals received without furnishing attested copies of relevant page of Original Service Book shall be entertained.

- It has further been clarified by the Govt. of Odisha in G.A & P.G Deptt. vide their L.No.5179/Gen., dtd:14-02-2020 that, the base level Junior Assistant post (Level-4) has been taken as 100% and accordingly, 04% of total sanctioned strength of Junior Assistant will be created as "Establishment Officer" and 0.5% of total sanctioned strength of Junior Assistant will be created as "Sr.Establishment Officer".

I am to therefore request you to please furnish the sanctioned strength of Revenue Assts. in the following format latest by 20th June'2020 for creation of post of Establishment Officer and Sr.Establishment Officer:
