Ref: Your Whatsapp message to ADM (Gen.), Ganjam on 29.04.2020.

Sir,

In inviting a reference to the above whatsapp message to ADM (Gen.), Ganjam on 29.04.2020, I am intimating the following facts as available from this office records regarding your incumbency as WEO in Ganjam District for your information and necessary action.

You have posted in Ganjam District as WEO in 3 (Three) blocks namely Sanakhemundi, Patrapur & Rangeilunda for the period from 1992 to 1997. During your incumbency in altogether three blocks, either you have been suspended for negligence in duty or disciplinary proceedings have been initiated against you as revealed from official records as mentioned below:

1. During your incumbency as WEO, Sanakhemundi for the period from 1992-93, you were suspended from Govt. service vide Order No-4853/H&TW dated 23.10.1992 of Collector, Ganjam. Again draft charges were framed against you in 4 (Four) points for initiation of D.P vide the Panchayat Samiti, Sanakhemundi Letter No.1319 dated 01.06.1994. However, you were reinstated vide Office Order No-185/H&TW dated 16.01.1993 & posted as such at Patrapur block in MADA.

2. During your incumbency as WEO, MADA, Patrapur block of Ganjam District for the year from 1993 to 1996, one D.P was initiated against you by BDO, Patrapur vide the Memorandum No.4029 dated 30.11.1996 on following charges:

- a) Un-authorized absence from Govt. duty from 22.12.1995 to 25.12.1995.
- b) Disobedience of orders of higher authority.
- c) Gross negligence in Govt. duty.
- d) Malafide intention in submission of vouchers.
- e) Un-authorisedly removal of Govt. papers from your personal file.
- f) Mischievous tendency in dealing with official records.

The said D.P is still pending against you.

3. During your incumbency as WEO, Rangeilunda for the period from 1996-97, one D.P was initiated against you vide Memorandum No-3454 dated 23.12.1997 of Collector, Ganjam. The said D.P is still pending against you.

4. Further, during your incumbency as WEO in Rayagada block of Gajapati District, one D.P was initiated against you in which the Inquiring Officer has proposed the punishment "*The Delinquent Officer be removed from Govt. service*". Due to non service of the said order, Govt. of Odisha in ST & SC Development Department had published the said 2nd Show cause notice in the Odia daily The Samaj dated 20.09.2018 vide Department No-18006 dated 20.09.2018 (Copy enclosed). it is pertinent here to mention that the notice of Govt. in ST & SC Development Department issued vide Memorandum No-13706/SSD dated 27.04.2011 could not be served upon you for want of your proper residential address and the same was returned to the Govt. with proper evidence for which Govt. have published the same in Odia daily news paper. The above draft clearly tells about your malafide service records (Copy enclosed).

5. It is revealed from official file that throughout your service tenure in Ganjam District, you have never performed your official duty properly. Even, your residential address as not given to any DDO for which no official correspondence could be made with you. You have only filed various petitions & RTI claims to justify your claims rather avoiding the personal presence in previous offices for settlement of your so called claims may be known or unknown to the concerned offices as it is the matter of a prolonged period of 25 years. It is worthwhile to mention here that the transfer of Service Book from one block to another after the transfer of concerned WEO to the blocks concerned, settlement of different personal claims of a WEO as mentioned by you is the duty of concerned block, not the matter of record of the District Office as BDO is the controlling Officer & DDO off concerned WEO. So, the details regarding your service book is not available in this office.

6. I have also personally discussed with BDO, Patrapur & Rangeilunda in this regard. BDO, Rangeilunda replied that Sri Pattnaik has served as WEO in Rangeilunda block in the year 1996-97, only for 6 to 7 months. His service book has not received in his office. It is not also available in official records about the receipt of your service book in Rangeilunda block. He had also called Sri Pattnaik over telephone to his office for settlement of his personal claims if any but, Sri Pattnaik did not turn up.

7. However, this office has intimated the Department vide this office Letter No-562 dated 02.03.2020 for complying information about the service period, the D.P drawn against him and any notice given by the Department to him etc.

8. After 23 years of your departure from Rangeilunda block, the Block Development Officer, Banarpal in the District of Angul has sought for the LPC & Service Book from the BDO, Rangeilunda vide his Office Letter No-911 dated 11.04.2020 for preparation of an information in response to the RTI application of your legal consultant. (Copy enclosed)

9. As the BDO is the DDO of the establishment of block in which WEO is a part, your representations have been forwarded to concerned BDOs vide this office Letter No-804/SSD dated 19.03.2020 for settle your claims. Hence, you are requested to peruse the matter with both the blocks for settlement of your claims.

10. It is further to intimate that, one Govt. employee must be having an updated duplicate service book with himself to produce when the original service book is not traced out or to update the same. Hence, you are informed to submit the updated duplicate service book with you in your last station of service with proper acknowledgement under intimation to this office for verification in the concerned offices to update your original service book.

11. You are also informed to intimate the stations with period of incumbency in which you have been posted after Ganjam District till end of your service period to verify the service records.





ARTICLES OF CHARGE

Annexure-I

Shri Manas Ranjan Pattnaik WEO, Rayagada Block, Gajapati has committed the following irregularities.

That Manas Ranjan Pattnaik, Ex-WEO, Talcher was transferred and posted as such vide this Deptt. order No. 9304 dated 4.2.2006. Without being relieved from the post of WEO, Talcher he joined as such at Cuttack Sadar on 20.2.2006 keeping fabricated facts before the BDO Cuttack Sadar. Due to non submission of relieve order from B.D.O Talcher, he was again relieved from Cuttack Sadar on 31.5.2006. Being relieved from Cuttack Sadar he has neither joined his old station i.e. WEO, Talcher nor submitted any leave application for his absence in the office. Subsequently he was transferred and posted as WEO Rayagada Block in Gajapati District vide this Deptt. order No.26892 dated 28.7.2007 and he joined before the Collector, Gajapati on 27.2.2009 after lapse of more than 1 ½ years. During that period he was neither present in office nor remained on leave and he has never reported his inconvenience to his immediate authority. Subsequently he was posted as WEO, Rayagada Block in Gajapati District and reported for duty on 29.3.2006. After that he was deputed to ITDA, Parlakhemundi on 25.10.2009 to monitor the work relating to Forest Right Act. He did not take any interest to carry out the orders of higher authority properly. Rather he remained absent unauthorizedly in ITDA w.e.f 25.2.2010. The PA ITDA Paralakhemundi relieved him on 25.3.2010 with direction to report before the Collector, Gajapati. Without obeying the orders of higher authority he remained absent for indefinite period. His whereabouts are not known to the authority till date. In this connection a number of correspondences have been made to his permanent address but no reply to this effect is received for which a lot of Govt. works is hampered.


That Sri Pattnaik has made a number of correspondences with Govt. with regard to non drawal of his salary and non entrustment of duty. In this context he has been informed to appear before the Director ST & SC for personal hearing twice. But he never appeared before the authority concerned. Further due to non receipt of any reply and non joining in the Govt. service till date a Notice has been sent to I & PR Deptt. for necessary publication in the daily

STATEMENT OF IMPUTATIONS OF MISCONDUCT

1. After issue of several instructions issued by the authority in regard to joining in different places he did not carry out any order and remained absent unauthorizedly without intimating any reason thereof. His whereabouts are not known to his authority.

2. He has also been informed to appear before the Director ST & SC in two occasion vide ST & SC Development Deptt. letter No. 44244 dated 4.12.2010 and No.758 dated 7.1.2011. Due to his adamant nature he did not appear before the authority. Further he is also not receiving any correspondence made from Govt. which returns with remarks that wrong address though the address is correct. It proves his callousness towards Govt. instructions

He was also intimated through a notice published in two local dailies viz, "The Samaja" and "The Dharitri" (dtd. 08.09.2018) to receive a copy of the 1st Show Cause Notice within 7 days of publication of the said notice and submit his representation against the findings of the Inquiring Officer.

And whereas the Delinquent Officer has not received the 1st Show Cause Notice and has not submitted his representation within the stipulated time.

And whereas after careful consideration of article of charges, enquiry report of the Inquiring Officer, the Disciplinary Authority has proposed to award the following punishment on the Delinquent Officer.

- 1. The Delinquent Officer be removed from Government service.
