Executive Engineer, Minor Irrigation Division, Ganjam-II Berhampur on behalf of Governor of Odisha invites **on-line percentage rate** tender for the Construction of Minor Irrigation Projects works through e-procurement as per Annexure to this bid Notice. The bid should be submitted online in the website www.tendersorissa.gov.in by **A, B & C** Classes of contractor. The bidders should have necessary Portal Enrolment (with his own Digital Signature Certificate).The registered bidders of outside Odisha can also participate in this process after necessary Portal Enrolment , but shall have to subsequently undergo registration with the appropriate authority of the State Government within a month of acceptance of bid.

Bid documents consisting of qualification information and eligibility criterion of bidders, the schedule of quantities of estimate of the various classes of work is available in website www.tendersorissa.gov.in from **20.12.2022 to 04.01.2023** up to **5.00 P.M.** The set of terms and conditions are also available in the web site till last date of submission of Bid.
3. The bid for the work shall remain open for acceptance for a period of ninety days from the last date of receipt of bids. If any Bidder / Tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited. Conditional Bid is subject to forfeiture of E.M.D.
4. **Exemption of E.M.D.** To avail the exemption of E.M.D, the intending Engineering contractor should have to furnish an affidavit to the effect that he has not been awarded works maximum up to 3 Nos. During the current financial year along with the tender paper failing which their case will not be considered for exemption of EMD. The successful Engineering Contractor shall have to submit the original registration licence before drawl of agreement for making necessary entry in it towards EMD exemption failing which his tender will be cancelled and the registration authority will be moved for taking penal action against him.
5. **Additional Performance Security** shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of the APS in the rates as noted below in shape of **Post Office Savings Bank Account/National Savings Certificate/Post Office Time Deposit Account/Kisan Vikash Patra/Deposit Receipt of Scheduled Bank** of any scheduled Bank duly pledged in favour of Executive Engineer M.I.Division

Ganjam-II Berhampur within 7 (seven) days of issue of letter of acceptance (LAO) otherwise the bid shall be forfeited. Further proceeding for blacklisting shall be initiated against bidder as per works deptt. OM No 4559 dated 05.04.2021.

6. Bidders registered as SC, ST& P.H contractors desiring to avail concession(S) /price preference as per prevailing rules should also clearly mention regarding claim for avail such benefits in writing in shape of an affidavit and enclose necessary document and affidavit in support of their claim along with their bid, failing which their case will not be considered for availing price preference as per the above rule. No claim in this regard after opening of bid will be entertained.
7. If the rate quoted by the bidder is less than 15% of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on the merits of rest of bids. But if more than one bid is quoted at **14.99% (decimals up to two numbers will be taken for all practical purposes)** less than the tendered amount, the tender will be finalized through a transparent lottery system in presence of all bidders/their authorized representatives, the Executive Engineer and DAO.
8. If the rate quoted by the SC and ST category contractors come to 14.99 % (decimals up to two numbers will be taken for all practical purposes) less than the estimated cost after availing 10% price preference as per Para-2 of Works Department Resolution No. 27748 dt. 11.10.1977, then the tender shall be finalized by the tender accepting authority through a transparent lottery system along with other category of contractors whose rates are 14.99 % less than the estimated cost in presence of all bidders/ their authorised representatives, the Executive Engineer and DAO.
9. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the state Government is allowed to work as a contractor for a period of two years after his retirement from Government service without Government Permission.

11. **Clear scanned copies of tender PAN, valid and active GSTN certificate, no relation certificate in shape of affidavit, original valid contractor registration certificate with online registration in CDMS portal, affidavit regarding authenticity of document, and affidavit to avail price preference** in case of SC & ST contractors should be uploaded **for each work separately** along with the Bid document.
12. If L1 bidder does not turn up for agreement after finalization of the tender, then he shall be debarred from participation in bidding for three years and action will be taken to blacklist the contractor. In that case, the L2 bidder, if fulfils, other required criteria would be asked for drawing agreement for execution of the work if he negotiates at par with the rate quoted by the L1 bidder otherwise the tender will be cancelled. In case a contractor is black listed, it will be widely publicized and intimated to all department of Government and also to Govt. of India agencies working in the State.
13. Before acceptance of tender, the successful bidder will be required to submit a work programme and milestone basing on the financial achievement so as to complete the work within the stipulated time and in case of failure on the part of the agency to achieve the milestone liquidated damage will be imposed.

14. The original affidavit regarding correctness of all documents for each work separately should be made and scan copy of such affidavit is to be uploaded online failing which his tender will not be considered and rejected during opening of tender.
15. Consequent upon implementation GST with effect from 01.07.2017, the rate offered by the agency should be excluding all taxes and duties and including labour cess and royalty, G.S.T as applicable shall be paid extra and TDS as applicable shall be deducted from the bill.
16. The Scan copies of valid Regd. CDMS Certificate, valid and active GST registration certificate, PAN , affidavit including all required paper uploaded through website of the valid successful lowest bidder should be produced in original to the Executive Engineer, M.I.Division, Ganjam-II, Berhampur within 5 days of opening of tender. In the eventuality of failure of the lowest successful bidder to produce the original document will be debarred in future from participating in tendering for 3 years and will be black listed by the competent authority.
17. The single tender received shall be cancelled without opening the bid in 1st call.
18. Agreement will be drawn/works will be taken up as per availability of funds.
19. The authority will not be held responsible for any technical snag or network failure during online bidding.
20. Quality control tests as per specification for all items of the work executed will be taken in nearby Government Quality Control Laboratories of Minor/ Medium/ Major Irrigation organization. It is binding on successful bidder to extend all necessary support in getting the tests done till completion of the work in all respect at his own cost.
21. Successful tenderer will be intimated for executing agreement.
22. The tenders will be processed/ considered as per office memorandum issued by the works Department Govt. of Odisha vide No. 12366 dated 08.11.2013.
23. As per works department memorandum no 17254 dated 05.12.2017 all bidder should pay the required tender paper cost and EMD through online mode only, instruction to be followed for online payment available in the e Procurement portal during processing of tender by the bidder.
24. If the office happens to be closed on the last date of closing or opening of the bids as specified, holiday in Government local authority the tenders will be closed or opened on the immediate next working day at same time and venue respectively, as the case may be.
