

TENDER CALL NOTICE

Interested Private Medicine Shops of Berhampur situated near MKCG Medical College Hospital, Berhampur who fulfill required criteria as per information, terms and conditions are required to submit their tender paper on their firms letter head to the undersigned in sealed covers for **Supply of Medicine, Injectable and Implant items** for this hospital. The last date of receipt of the tender through Regd. Post / Speed Post or Courier is on 12.01.2023. The tender will be opened on 13.01.2023 or it may be extended. If the opening day falls on a public holidays, then the technical Bid will be opened on the next day in the office chamber of the undersigned. The Price Bid will be opened of the firm which qualifies in the technical Bid. Both the Technical Bid and Price Bid will be opened in presence of the committee and bidders. The tender papers will be of 2 (Two) bid system i.e. Technical Bid and Price Bid. The Technical Bid Should be superscribed as **TECCHNICAL BID FOR SUPPLY OF MEDICINES, INJECTABLE AND IMPLANT ITEMS** and Price Bid should be superscribed as **"PRICE BID FOR SUPPLY OF MEDICINE, INJECTABLE AND IMPLANT ITEMS"** both are duly sealed separately and should be submitted in a third outer sealed cover which should be superscribed as **"TENDER PAPER FOR SUPPLY OF MEDICINE INJECTABLE AND IMPLANT ITEMS"**.

Those bidders who downloads the tender papers from websites:- www.ganjam.nic.in may deposit the tender cost of Rs. 2360/- including GST (Two thousand three hundred sixty) is non-refundable to be paid by way of E-Challan under the Head Of Account 0075-00-800-0097-02237-000 through Odisha Govt. Treasury Site. The undersigned reserves the right to accept/reject/ cancel/ modify any or all in part or full of the tender without assigning any reason thereof. The Tender value is around 5 cores per annum.

Terms And Condition:

1. The Private Medicines Shops should be within radius 1 KM. from Medical Campus of MKCG Medical College Hospital, Berhampur.
2. The Private Medicine Shops should possess valid Drug License from the Competent Authority under Drugs & Cosmetic Act by the Govt. of Odisha.
3. Stocks of commonly prescribed Medicines and Injectables and implant of M.K.C.G. Medical College & Hospital, Berhampur should be maintained by the Medicine Shops at all cost.
4. In case of required medicine is not available in the Empanelled Store, they should take immediate steps to procure from Local Market and supply.
5. It will be the responsibility of the Empanelled Medicine Store to supply the Medicines & Injectable to the Main Medicine store of the M.K.C.G. Medical College & Hospital, Berhampur through their employees immediately within 24 hr. on receipt of orders in any form on proper receipt.
6. The Medicine Shops must have computer with internet facility, so that the purchase orders will be sent via E-mail for immediate service / delivery.
7. Medicines for each patient is to be packed separately and computerized bill in triplicate mentioning the purchase price and the sale price of the drug must be attached with the medicines.
8. The Medicine Shops should submit annual turnover certificate of more than 10 Lakhs from the Chartered Accountant during last 1(one) Assessment Year.
9. The Medicine Shops are to submit the Clearance of last 3 years IT return.
10. The Medicine Shops should submit the Up-to-Date GST Certificate.
11. The Medicine Shops should submit EMD 1,00,000/- by (DD) and the same is return soon after the Tender process is complete to the unsuccessful medicine shop.
12. The Medicine Shops must supply the medicine having long expire period and of a reputed, popular and leading pharmaceutical company with wide availability.
13. The medicines, Injectables and others with lower price range of the items available in the market should be supplied.
14. Three Private Medicine Shops will be selected, as per L-2/L-3/L-4 firms to supply at L-1 rate. The Medicine store should have a capacity to supply not less than 90% of the commonly prescribed medicine, injectable and other items as per the need of this hospital and preference shall be given to the medicine store who will take less percentage of profit on the purchase price.
15. The committee will not accept the discount offered by medicine shops if it is not viable.
16. The private medicines shops are to submit the ISO/ISE Certificate of company.
17. Superintendent, MKCG MCH, Berhampur reserves the right to accept /reject/ cancel any or all the tenders in full or part without assigning any reason thereof.

18. Legal disputes, if any are subject to jurisdiction in the courts of law situated at Berhampur, Ganjam, Odisha.
19. The Private Shops are to submit the Certificate of distance (1 KM) from Competent Authority.
20. If more than one supplier are empanelled, in such case purchase will be made on monthly rotation basis.
21. The payment will be released subject to availability of funds/allotment as well.
22. No advance payments towards cost of items will be made to the supplier. Payment shall be made on receipt of the stock entry certificate on the body of the bill/invoice from the store.
23. The Medicine Shop fails to supply required articles within the prescribed time, and reputation of the same, steps will be taken to Black List the Shop.
24. The Selected Medicine Shops should deposit of Rs. 2 Lakhs as security deposit(FD/NSC) in any nationalised bank pledge in favour of Superintendent MKCG MCH, Berhampur. Which is mandatory and should submit the agreement papers before Superintendent, MKCG Medical College Hospital, Berhampur.
25. The EMD & Security Deposit will be forfeited, in case the successful Medicine Shops fails to execute the order within the stipulated period.
