OFFICE ORDER

Sub:-Wide publicity of identified eligible HHs for Public scrutiny through objection invitation before issuance of work orders under PMAY-G.

In adherence to letter no 0180 Dt.12-01-2023 of Director Special Projects, PR & DW deptt, following staffs are hereby constituted to be a team of three numbers in each respect of GPs mentioned against their name to conduct enquiry immediately after receipt of complaint from complaint box instituted at GP level. Progress and conduct of enquiry by each team will be monitor through RH portal on daily basis i.e. Dt. 16.01.2023 to 28.01.2023.

The enquiry officer-1 (as per annexure -1) shall be in-charge of receiving objections during the publication period i.e. Dt.16.01.2023 to 24.01.2023 at GP. He/She shall supply standard form available at Grama Panchayat and informed public to put their objection in the box through by hand written form as per Prescribed format .The enquiry officer-1 also need to maintain register to record the complaints. The box will be opened every day at 4 PM in the presence of Sarapancha , PS member and other PRI member, reputed persons depending on their availability .The objection received on every day will be counted and report to block office in standard certificate (as per annexure-2) by 5 P.M by the enquiry officer -1. The team shall conduct joint enquiry within the publication period and shall be over latest by 28th January 2023.

AEE-cum-RH nodal Officer, DA-RH, BPC, BPA are instructed to monitor the entire Process as per standard operating procedure of the department and report compliance to undersign on every day. An advisory issued by the PR & DW department is enclosed regarding detail Publication process and other follow up measures on the objections received which should be strictly adhered.
