

Term and Condition


1. The Tender is to be super scribed with the name of the work and item of work tendered for.
2. Registered Contractor of Class B & C, can obtain tender documents for the work either from Office of the Panchayat Samiti, Aska or from the official web site (<http://www.ganjam.nic.in>) in all working days during office hours from 28.03.2023 to 15.04.2023 on payment of the Cost as indicated in the table in shape of cash/A/c payee DD (Non -refundable) drawn in favour of Block Development Officer, Aska.

3. The intending purchasers are not required to produce any documents viz copy of Registration, valid GST clearance certificate etc. at the time of purchase of tender documents.
4. The Tender shall be accompanied by EMD for an amount as stipulated above for each work in shape of NSC/Postal Saving Pass Book/ Post Office Time Deposit/ KishanVikashPatra/ Deposit receipt in Schedule Bank only. duly pledged in favour of Block Development Officer, Aska Attested copies of valid ITCC/ PAN Card/GST Clearance Certificate/Valid license, Without which the tender is liable for rejection. The tenderer shall furnish an affidavit at the time of submission of tender paper about the authentication of tender document.
5. The tender shall be received in a sealed cover through Tender Box (available at Block office) , in the office in all working days during office hour up to 15.04.2023 excepting holiday. The tender will be opened before the BDO, Aska on 17.04.2023 at 11.00 AM in presence of tender or their authorized representative. If any of the above dates will be declared as the Govt holiday then the next working day shall be considered for sale of tender paper, receipt and opening of the tender respectively.
6. The tender will be received in the Office of the BDO, Aska, Ganjam within the stipulated date and time by Tender Box(available at Block office). The tender shall be submit the required documents in a sealed cover subscribed with the name of Work only and it shall be ensure that the name of firms /bidder shall not be written anywhere on the sealed cover.
7. The tender received after due date and time shall not be entertain and the authority shall not held responsible for delay missing of tender during postal or courier transit.
8. Any bidder backs out from the office before acceptance of the tender, the EMD along with the other deposit, deposited by him will be forfeited.
9. Engineering contractors during intending to avail the exemption facility of EMD should apply specifically their application with an affidavit and submit the same with tender documents. He should also produce original contract license at the time of opening of tender document to make necessary entry to that affect as such facilities are limited to their participation in the tender during a financial year, otherwise the tender will be rejected on the spot during opening of the tender.

11. No telegraphic / fax tender shall be entitled.
12. The tender paper received without signature of the Contractor/agency will not be entertained.


