Sealed quotations are invited for the disposal of the aforesaid vehicle on the terms and conditions mentioned below. Firms/Persons interested to buy the aforesaid vehicle is required to submit their highest quotations in the enclosed proforma addressed to the Sub Divisional Veterinary Officer, Chatrapur Near Upper Bus Stand, Chatrapur Dist-Ganjam, PIN-761020 by Regd/Speed post and the same should reach in this office on or before 05-06-2023. The sealed quotations will be opened on 07-06-2023 at 3.00 PM in the office chamber of Sub Divisional Veterinary Officer, Chatrapur. The vehicle is available for inspection from 11.00 AM to 3.00 PM on all working days.

The Bidders may submit their original bids/applications along with an Earnest Money of ₹2500/- by way of Demand Draft in favour of Sub Divisional Veterinary Officer, Chatrapur. The Bidders or their representatives (not more than one) may present, if they so desire at the time of opening of quotations. The undersigned reserves right to open the quotation if any Bidder/ Representative fails to attend on the schedule date and time.

The auction will be governed by the following conditions: -

- The successful Bidder will be required to deposit the balance bid amount after deducting the earnest money of ₹ 2500/- latest within one week of intimation about successful bidder by way of Demand Draft drawn in favour of Sub Divisional Veterinary Officer, Chatrapur.
- The delivery of the sold vehicle will be given only to the successful H-1 Bidder after submission of documentary evidence in support of residential status (Ration Card/ Voter Identity Card/Aadhar Card) in case of individual and Registration Certificate in case of Firms etc.
- The Sold vehicle shall have to be removed by the successful Bidder immediately at his own expenses from the office premises within seven days.
- Failure to remove the vehicle within the time as aforesaid ground rent @ 1% (One per cent) of the tendered money shall be charged for each day or part of the day till the removal of the vehicle from the site. Where the ground rent so charged exceeds the sale price deposited by the bidder shall cease to have any right on the vehicle. The amount deposited shall be adjusted towards the ground rent and the vehicle shall become absolute property of the Govt. free from all encumbrances and disposed of by fresh sealed tender.

- vi) The successful Bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. The undersigned will not be responsible for any lapse on his part in this regard. This Office will not be liable for any mishap / accident etc. After delivery of vehicle
- vii) The successful Bidder shall not be allowed to withdraw his bid, failing which the earnest money will be forfeited.


