Firms/Persons interested to buy the aforesaid vehicle is required to submit quotations in the enclosed format annexed in **ANNEXURE-I** addressed to the Chief District Veterinary officer, Ganjam, Berhampur, 2nd Military line, Bhimarao Petta, Berhampur, 760001 by Registered Post /Speed post/Courier servc and the same should reach in this office on or before 28.08.2023 up to 3 PM. The sealed quotations will be opened on 29.08.2023 at 11.00 AM in the office chamber of Chief District Veterinary officer, Ganjam, Berhampur. The vehicle is available for inspection from 11.00 AM to 3.00 PM on all working days.

The Bidders should submit their original bids/applications along with an Earnest Money of ₹2500/- by way of Demand Draft drawn in any nationalised bank in favour of Chief District Veterinary officer, Ganjam, Berhampur. The Bidders or their representatives (not more than one) may present, if they so desire at the time of opening of quotations. The undersigned reserves the right to open/reject the quotation of any Bidder/ Representative who fails to attend on the schedule date and time fixed for opening of sealed quotation.

The auction will be governed by the following conditions: -

- i) The highest rate quoted by the bidder above the upset price shall be accepted & confirmed.
- ii) The quotation cover should be superscripted as "Quotation for the purchase of Govt. vehicle".
- iii) The highest bidder is required to deposit 25% of offered amount of the vehicle immediately after sale is confirmed & the rest amount within 7 days from the date of acceptance of highest offered price.
- iv) The successful Bidder will be required to deposit the balance bid amount after deducting the earnest money of ₹ 2500/- latest within one week of intimation about successful bidder by way of Demand Draft drawn in favour of Chief District Veterinary officer, Ganjam, Berhampur.
- v) The delivery of the sold vehicle will be given only to the successful H-1 Bidder after submission of documentary evidence in support of residential status (Ration Card/ Voter Identity Card/Aadhar Card) in case of individual and Registration Certificate in case of Firms etc.
- vi) The Sold vehicle shall have to be removed by the successful Bidder immediately at his own expenses from the office premises within seven days.
- vii) Failure to remove the vehicle within the time as aforesaid ground rent @ 1% (One per cent) of the tendered money shall be charged for each day or part of the day till the removal of the vehicle from the site. Where the ground rent so charged exceeds the sale price deposited by the bidder shall cease to have any right on the vehicle. The amount deposited shall be adjusted towards the ground rent and the vehicle shall become absolute property of the Govt. free from all encumbrances and disposed of by fresh sealed tender.

- viii) The earnest money Bank draft of the un-successful bidder will be returned on the same day.
- ix) The vehicle will be disposed of "as is where is basis" and no guarantee for its worthiness or quality will be given by this Department.
- x) The successful Bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. The undersigned will not be responsible for any lapse on his part in this regard. This Office will not be liable for any mishap / accident etc. after delivery of vehicle
- xi) The successful Bidder shall not be allowed to withdraw his bid, failing which the earnest money will be forfeited.
