## TERM & CONDITIONS FOR HIRING OF VEHICLE

The following terms and conditions must be fulfulled by the successful bidder for providing a vehicle on hire on monthly rent basis.

- 1. The hired vehicle, during period of contract, shall have all necessary valid MV document such as:- valid Registration Certificates, Insurance Certificate, Valid Contract Carriage Permit, Pollution Certificate proof of up-to-date tax payment etc. and D.L. of the driver available all the times. The Department / Office hiring the vehicle shall not be responsible for any damage/ loss caused to hired vehicle of losses of life /injury made to any person of damage to any property on account use of hired vehicle and manner whatsoever. The hirer shall be responsible for all such litigation.
- 2. The hire charges to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separatly basing on actual consumotion and lubricants as per exiting Government norms. All the expenditury of the vehicle toward repaid, replacment of spare parts, Lubricating oil of engine, Gear Box & different Coolant, Tyres & Tubes, Battery etc. will be borne by the bidder.
- 3. It shall be the responsibility of the bidder to provied a good driver and the salary of the driver shall be borne by the owner.
- 4. In case of breakdown for reasons whatsover the replacement of a vehicle of the same or better modle shall be provided by owner of the vehicle / bidder.
- 5. In case of vehicle do not report regularly will be at liberty to reject the arrangment and may engage vehicle from other sources.
- 6. The vehicle shall report for duty for minimum of 30 days in a month.

- 9. TDS 2% deduction is appllicable as per income Tax Act.
- 10. The vehicle shall not be more then 03 year old from the intial registration and also in good running condition during the period of contract.
- 11. If the services are found to be unsatisfactory, the clint shall give one month notice and termenate the agrrement.
- 12. In case the service provider intend to withdraw the service of his vehicle and terminate the arrangment, it shall be mandatory upon him to grant one month notice before such withdrawal of service and trmination of arrangment.
- 13. If the bidder violates any of the terms of contract, Govt. shall forfeit the entire amount of security deposit.
