



## Terms & Conditions:

1. Brochure containing relevant information, terms and conditions and application form etc can be obtained from the office of the R.M.C.Hinjilicut on submission of Non-refundable application form cost of Rs.500.00 (Rupees five hundred) only for each Solar Cold Room in shape of demand draft drawn in favour of "Secretary, R.M.C.Hinjilicut" in any nationalized bank in any working day from 11.00 AM of 28.06.2024 to 3.00 PM of 09.07.2024. The same can also be downloaded from the District Website [www.ganjam.nic.in](http://www.ganjam.nic.in).
2. The application downloaded from the website is required to submit the Non-refundable application form cost of Rs.500.00 (Rupees five hundred) only for each Solar Cold Room in shape of Bank Draft drawn in favour of "Secretary, R.M.C.Hinjilicut" along with the application form.
3. The filled applications should reach to the address Secretary, R.M.C.Hinjilicut At/Po-Hinjilicut Dist- Ganjam Pin-761102 in sealed cover on or before 10.07.2024 (up to 4.pm) through Registered Post/ Speed Post only.
4. The applications shall be opened at 11 AM of 11.07.2024 at R.M.C.Hinjilicut.
5. It is required to apply for Cold Room, the applicant is to enclose xerox copy of PAN, GST, Aadhar/EPIC.
6. The upset price fixed for the each Solar GI Cold Room is **RS. 18,000.00 (Rupees eighteen Thousand)** only per month.
7. Allotment of Cold Rooms shall be made on the basis of closed tender process. The intending tenderer is required to quote the monthly rate in figures as well as in words excluding taxes. Taxes will be charged extra if applicable.
8. The applicant has to submit the filled in form as attached in the Annexure-I duly signed along with all the requisite documents/ annexure in a sealed envelope superscribed "**APPLICATION FOR ALLOTMENT OF COLD ROOM IN SUB-MARKET YARD, CHATRAPUR/HARIPUR BURUDI UNDER R.M.C.HINJILICUT**" addressed to the Secretary, R.M.C.Hinjilicut At/Po-Hinjilicut Dist-Ganjam Pin-761102.
9. RMC will hand over the said Cold Room to the highest offered price on monthly rental basis of lease.

10. Conditional / incomplete tender will not be entertained.
11. Usage of the Cold Room shall be for activities related to flower, Vegetables, Fruit, Agri-items.
12. Cold Rooms will be handed over with all facilities "as is where is" basis mentioned above.
13. The lessee will have right of possession of the Cold Room. The land area and other space belong to RMC. All assets will belong to RMC, The Lessee will only have user right.
14. The bidder with highest bid will be selected for lease of the Cold Rooms provided other conditions are fulfilled.
15. The lessee will have the option of renew the lease on expiry of lease period subject to terms & conditions to be decided by the lesser at that time.
16. A lease agreement will be executed and the possession of the Cold Rooms will be given to the lessee only after full payment of the Security Deposit fixed as per agreement and fulfillment of the terms & conditions herein and compliance of required formalities. Lease rent for successive month will be made by lessee by 10<sup>th</sup> of each month.
17. The Lessee has to make necessary security arrangement of the said cold store from its own source.
18. The payment of wages of the technical personnel appointed through outsourcing basis shall be equally borne by the lessee.
19. The Lessee has liberty to undertake building / commodity insurance for the cold store building as applicable. The Insurance premium charges have to be borne directly by the lessee. Copies of the insurance certificate and receipt of the payment made have to be submitted to RMC.
20. An interest free refundable security deposit of Rs. 1,00,000/- (Rupees One Lakh) only for Cold Room to be deposited to RMC. This deposit will not be adjustable with any other charges and will be refunded against the cancellation of lease deed agreement between RMC and the lessee.
21. The lessee shall keep neat and clean of the area in his/her possession at their own cost.



22. The power meter of the said cold store is in the name of Secretary RMC. On Receipt of the power meter bill from SOUTHCO it is the responsibility of the Lessee for necessary payment to SOUTHCO. The copy of the payment receipt of the said electricity bills have to be submitted to RMC.
23. For telephone connection (If necessary), the lessee shall be required to apply separately and necessary deposit and fees have to be paid to the concerned authority for the telephone connection.
24. The Lessee will bear the cost of stamp duty etc., for execution of Lease deed.
25. The Lessee would replace all token fittings and fixtures by good substitute of not less than equal value at their own cost. The changes in major machinery the lessee has to take prior written permission of RMC.
26. The Lessee will maintain books of records including the daily inward and outward register. The Lessee will always give permission to the representative of RMC to enter into the said Cold Room to inspect the conditions and all books of records immediately.
27. The Lessee must provide equal opportunity of use of the Cold Room to all concerned. A register showing the name of users in the waiting must be maintained.
28. The RMC will have the right to process vegetables / fruits / other things at a concessional rate and with priority.
29. The lessee would not construct any permanent structure at the open space inside the Yard without prior written permission of RMC.
30. RMC will hand over all the Cold Store and machineries including fixtures and fittings, electrical equipment and fittings, of the premises and all other things taking possession on execution of Lease Deed in running condition to the lessee and in turn the Lessee will also hand over the same in good and running conditions to the RMC immediately after expiry of lease period.
