The Company reserves the right to recover loss up to the amount of Performance Security in case the quality is low or in case of deficiency of service.
2. Irrespective of the fact as to whether or not the Company makes purchases from outside, the Company may impose penalty up to 1% per week subject to maximum of 10% of the total cost, for delayed delivery, if the delay is due to wilful laches or negligence on the part of tenderer, and if it causes financial loss or inconvenience to the Company.
