4. The Tender shall be accompanied by EMD for an amount @ 1% as stipulated above for each work in shape of NSC/Postal Saving Pass Book/ Post Office Time Deposit/ Kishan VikashPatra/ Deposit receipt in Schedule Bank only. Duly pledged in favour of Block

Development Officer, Sanakhemundi attested copies of valid ITCC/ PAN Card/GST Clearance Certificate/Valid license.

5. The tenderer shall furnish an affidavit at the time of submission of tender paper about the authentication of tender document.
6. The tender document shall be received in a sealed cover through registered/ speed post only, to the above office in all working days during office hour from **20.09.2024 to 30.09.2024 till 4 PM**. The tender will be opened in the office of the BDO, Sanakhemundi on **01.10.2024 at 11.00 AM** in presence of tender or their authorized representative. If a Govt. holidays declared during the above periods i.e from 20.09.24 to 27.09.24 then the next working day shall be considered for sale of tender paper, receipt and opening of the tender respectively.
7. The tender will be received in the Office of the BDO, Sanakhemundi, Ganjam within the stipulated date and time by registered post /Speed Post. The tender shall be submit the required documents in a sealed cover subscribed with the name of Work only and it shall be ensure that the name of firms /bidder shall not be written anywhere on the sealed cover.
8. Any bidder if went out from the office during the acceptance of the tender, the EMD along with the other deposit, deposited by him will be forfeited.
9. Engineering contractors during intending tender to avail the exemption facility of EMD should apply specifically their application with an affidavit and submit the same with tender documents. He should also produce original contract license at the time of opening of tender document to make necessary entry to that affect as such facilities are limited to their participation in the tender during a financial year, otherwise the tender will be rejected on the spot during opening of the tender.

12. The tender paper received without signature of the Contractor/agency will not be entertained.


