The tender shall be accompanied by EMD for an amount as stipulated above for each work in shape of NSC/Postal Saving Pass Book / Post Office Time Deposit/ Kishan Vikash Patra / Deposit receipt in Schedule Bank only. Duly pledged in favour of Block Development Officer Kabisurya Nagar attested copies of veiled ITCC/ PAN Card/ GST Clearance Certificate / Valid License, without which the tender is liable for rejection. The tender shall furnish an affidavit at the time of submission of tender paper about the authentication of tender document.

5. The tender shall be received in a sealed cover through registered/ speed post only, in the above office in all working days during hour up to 4 PM excepting holiday. The tender shall be submitted the required document in a sealed cover subscribed with the name of work only and it shall be ensured that the name of firms/ bidder shall not be written anywhere on the sealed cover.
7. The tender received after due date and time shall not be entertain and the authority shall not held responsible for delay missing of tender during postal or courier transit.
8. Any bidder backs out from the office before acceptance of the tender, the EMD along with the other deposit, deposited by him will be forfeited.
9. Engineering contractors during to avail the exemption facility of EMD should apply specifically their application with an affidavit and submit the same with tender documents. He should also produce original contract license at the time of opening of tender document to make necessary entry to that affect as such facilities are limited to their participation in the tender during financial year, otherwise the tender will be rejected on the spot during opening the tender.


