

Registered Contractor of Class B & C can obtain tender documents for the work either from Office of the PanchayatSamiti, Patrapur or from the official web site (<http://www.ganjam.nic.in>) in all working days during office hours from 05.09.2024 to 25.09.2024 on payment of the Cost as indicated in the table in shape of cash/A/c payee DD (Non-refundable) drawn in favor of Block Development Officer, Patrapur.

The tender shall be accompanied by EMD for an amount as stipulated above for each work in shape of NSC/Postal Saving Pass Book/ Post Office Time Deposit/ KishanVikashPatra/ Deposit receipt in Schedule Bank only. Duly Pledge in Favour of Block Development Officer Patrapur attested copies of veiled ITCC/ PAN Card/ GST Clearance Certificat Valid License, without which the tender is liable for rejection. The tender shall furnish an affidavit at the time of submission of tender paper about the authentication of tender document.
5. The tender shall be received in a sealed cover through registered/ speed post only, in the above office in all working day during hour up to 25.09.2024 excepting holiday. The tender will be opened of the BDO, Patrapur on 26.09.2024 at 11.0 AM in presence of tender or their authorized representative. If any of the above dates will be declared as the Govt. holiday then the next working day shall be considered for sale of tender paper, receipt and opening of the tender respectively.
6. The tender will be received in the office of the BDO, PatrapurGanjam within the stipulated date and time by registered post/ Speed Post. The tender shall be submitted the required document in a sealed cover subscribed with the name of work only and it shall be ensured that the name of firms/ bidder shall not be written anywhere on the sealed cover.
7. The tender received after due date and time shall not be entertain and the authority shall not held responsible for delay missing of tender during postal or courier transit.
8. Any bidder backs out from the office before acceptance of the tender, the EMD along with the other deposit, deposited by him will be forfeited.

He should also produce original contract license at the time of opening of tender document to make necessary entry to that affect as such facilities are limited to their participation in the tender during financial year, otherwise the tender will be rejected on the spot during opening the tender.
