The Technical bids shall contain valid PAN CARD, Up-to-date GSTN certificate as per the Govt. rule, Up-to-date valid Drug licenses from Drugs Controller, Odisha, for Supply of Medical Gases and the certified copies of up-to-date valid license issued by the Chief Controller of Explosives, Petroleum and Explosives Safety Organization (PESO) for Supply of Medical Gases. The Price bids must contain (1) Name of the item, (2) Cost, (3) GST as per the Govt. rule, (4) Transportation charges per cylinder (as per given proforma). The intending tenderer should submit their tenders separately in two sealed covers duly superscribed as Technical Bid for "Supply of Life Saving Gases And Accessories" & Price Bid for "Supply Of Life Saving Gases And Accessories" putting in a single sealed cover. **Terms and conditions:**

1. The sealed tenders in prescribed proforma should be super scribed as Tender for “SUPPLY OF LIFE SAVING GASES AND ACCESSORIES” are to be submitted in the office of the undersigned on or before **13.11.2024 at 05.00 PM** through Regd. Post / Speed Post/Courier and the tender will be opened on 14.11.2024 at 12.30 PM in the office chamber of the undersigned and it may be extended.
2. The selected firms shall have to enter into an agreement and are to be deposit Rs. 1,00,000/- (Rupees One lakh) only as security deposit in shape of TDR/Fixed Deposit Certificates pledging in favour of the Superintendent, MKCG Medical College Hospital, Berhampur to handle the Govt. properties .The Security Deposit will be forfeited, in case the successful tenderer fails to execute the order within the stipulated period.
3. The tenders received after due date and time will not be considered under any circumstances and the price bid will be opened whose tender will be qualified in the technical bid.
4. The tenderers or their authorized representatives may attend on the date / time of opening of tenders. If any tenderer or their authorized representatives fails to turn up at the time of opening of the tenders, the process will continue as usual.
5. The tenderer should submit the attested Xerox copies of valid PAN CARD, Up-to-date GSTN Certificate as per the Govt. rule, Up-to-date valid Drug licenses from Drugs Controller, Odisha, for Supply of Medical Gases and the certified copies of up-to-date valid license issued by the Chief Controller of Explosives, Petroleum and Explosives Safety Organization (PESO) for Supply of Medical Gases, otherwise tender for the item will not be considered.
6. If any information or documents furnished by the tenderer found to be misleading/in correct at any stage their tenders will not be accepted.
7. The rates so quoted should be on door delivery at Main Medical Store of M.K.C.G. Medical College Hospital, Berhampur, Dist-Ganjam, Odisha.
8. The tender will be valid for one year from the date of approval / may be extended upto 2 year subject to review on mutual agreement with the same terms & condition subject to satisfactory performance.
9. The tenderer should adhere to the terms & conditions and to submit their consent along with the bids in given prescribed proforma failing which the Bid will be cancelled.

10. Tenderer who has been blacklisted either by the tender inviting authority or by any state Govt. or Central Govt. organization should not participate in the tender .
11. The tender documents should be clearly written/ typed without any corrections, interpolation and over-writings etc and each page of the tender should bear the date and signature of the tenderer.
12. The quoted rates should be in Indian Currency, both in words and figures against each items.
13. The price quoted should be final and shall not be subject to any escalation during the validity of the tender.
14. The tenderer should submit/ furnish a certificate in the tender to the effect that price quoted by him/ them is not more than the Open Market Price/Gem Price.
15. If the manufacturing firms are directly submitting the tender, they should not authorize any agent to quote for the same products simultaneously.
16. To ensure sustained supply without any interruption, the Superintendent reserves the right to split orders for supplying the requirements among more than one tenderer provided that the rates and other conditions of supply are equal and with sufficient grounds. In case of non supply of any items by any approved lowest quoted firm, the Superintendent can offer to any of L-2 firms to supply at L-1 rate (lowest approved rate) and procure the same items in L-1 rate sequentially.
17. No advance payment towards cost of items will be made to the supplier. Payment shall be made on receipt of the stock with due certificate on the body of the bill/invoice by the Store Medical Officer.
18. The payment will be released subject to availability of funds/ allotment as well.
19. The approved firm should ready to supply as per requirement of hospital with in 24 hours of placement of procurement order preferably during first hour.
20. All legal disputes, if any relating to purchase etc. are subject to jurisdiction in the courts of law situated at Berhampur, Ganjam, Odisha.
21. The Superintendent, M.K.C.G. Medical College Hospital, Berhampur reserves right to accept/ reject/ cancel any or all the tenders in full or part without assigning any reason thereof.
