25. 30. No compensation for any damage caused by the rains by similar action during the execution of work will be paid.
31. Letters found in the tender box intimating modification to the tender already given will not be entertained.
32. The Contractor shall made at his own cost housing accommodation and medical facilities for the labour engaged on the work.
33. The Contractor shall make arrangements at his own cost at work site for the proper storage of the materials made over to him till the work is completed and balance materials are returned to department if supplied by the department.

42. If any telephone cable or electric cable comes inside the trench alignment, the same should be intimated to the Engineer in charge at site and the contractor shall not claim for delay in shifting of the cable by the concerned department.
43. Sufficient labourer should be engaged for removal of rock and it should be completed within time.
44. Exemption of EMD to the Engineer contractor will be allowed for a maximum of three works in a financial year and the fact of awarding a work with Exemption of EMD should be entered in the Original Registration Certificate of the Engineer Contractor. Engineer contractor desirous to avail the exemption of E.M.D./ISD. is required to submit an affidavit to the effect that he/she has not yet availed the facility for more than two works during the current financial year

In such case, the successful Engineer Contractor has to produce the original Registration Certificate for recording the fact of availing exemption of E.M.D & ISD, for award of the work. Bidders registered as S.C. & S.T. 47. (i) Every bidder is expected before quoting his rate to inspect the site of the proposed work. The bidder should also inspect the quarries and approach roads to quarries and satisfy himself/himself about the quality and availability of materials. In every case the materials must comply with the relevant specifications. Complaints at future date that the availability of materials at quarries has been misjudged cannot be entertained.

(ii) For the purpose of estimate, the approved quarry lead is to be provided judiciously. Engineers in charge would be responsible for ensuring the quality of the materials supplied. The contractors would, however, be responsible for procurement of materials from authorized sources and voluntarily disclose the source of procurement for the purpose of billing. Besides, the bidder would be required to submit the details of quarry for procurement while submitting the bids.

50. Government will not however after acceptance of contract rate pay any extra charges for lead or any other reason in case the contractor is found later on to have misjudged the materials available.

51. All fittings for doors and windows if supplied by the contractor should be of best quality and should be got approved by AEE/AE, Beguniapada Block, Ganjam, before they are used on the work.

52. The tender containing extraneous conditions not covered by the tender call notice are liable for rejection.

2. With a view to avoiding these situations Govt. have been pleased to decide that with effect from 01.04.96 there will neither purchase of department store materials nor booking of materials to show utilization of budget provision. It will be the responsibility of the contractor to purchase stores and utilize them in the work since materials like cement, steel etc. are easily and abundantly available at places, there will be no difficulty for contractors to procure the same. Therefore the future agreement with the contractors shall be executed accordingly and necessary modification to the agreement from may be made. In case where agreement have already been executed for department supply of materials, efforts should be made to fulfill the same by utilization to the existing stores and also through inter divisional and even inter department transfer of stores. For utilization of the surplus materials, agreements may however be made for supplying of materials to the extent available. In this way the existing materials should be exhausted.

3. Maintenance work should be undertaken by purchasing materials in case of departmental execution of work by directly charging to site account or through contractors. There should not be advance purchase of materials for the sake of storing and utilizing the same in future works.





2. 





With a view to avoiding these situations Govt. have been pleased to decide that with effect from 01.04.95 there will neither purchase of department store materials nor booking of materials to show utilization of budget provision. It will be the responsibility of the contractor to purchase stores and utilize them in the work since materials like cement, steel etc. are easily and abundantly available at places, there will be no difficulty for contractors to procure the same. Therefore the future agreement with the contractors shall be executed accordingly and necessary modification to the agreement from may be made. In case where agreement have already been executed for department supply of materials, efforts should be made to fulfill the same by utilization to the existing stores and also through inter divisional and even inter department transfer of stores. For utilization of the surplus materials, agreements may however be made for supplying of materials to the extent available. In this way the existing materials should be exhausted.

3. Maintenance work should be undertaken by purchasing materials in case of departmental execution of work by directly charging to site account or through contractors. There should not be advance purchase of materials for the sake of storing and utilizing the same in future works.





2. 



Besides, the bidder would be required to submit the details of quarry for procurement while submitting the bids.

50. Government will not however after acceptance of contract rate pay any extra charges for lead or any other reason in case the contractor is found later on to have misjudged the materials available.

51. All fittings for doors and windows if supplied by the contractor should be of best quality and should be got approved by AEE/AE, Beguniapada Block, Ganjam, before they are used on the work.

52. The tender containing extraneous conditions not covered by the tender call notice are liable for rejection.

53. (a) The contractor shall have to furnish a certificate in the prescribed proforma enclosed herewith along the tender to effect that he is not related to any officers of Block Development Officer, Beguniapada Block Ganjam as per annexure-III

54. All the tenders received will remain valid for a period Sixty days from the date of receipt tenders. The period of validity can also be extended if agreed to by the Department and the contractor.

55. After completion of the work, the contractor shall arrange at his own cost all requisite equipments for testing building if found necessary and bear the entire cost of such test.

2. With a view to avoiding these situations Govt. have been pleased to decide that with effect from 01.04.96 there will neither purchase of department store materials nor booking of materials to show utilization of budget provision. It will be the responsibility of the contractor to purchase stores and utilize them in the work since materials like cement, steel etc. are easily and abundantly available at places, there will be no difficulty for contractors to procure the same. Therefore the future agreement with the contractors shall be executed accordingly and necessary modification to the agreement from may be made. 


