

- 1. Cost of Tender paper:** The tenders specification can be obtained from the office of the Block Development Officer, Ganjam on payment towards the cost of tender paper as mentioned above.(Non-Refundable) in shape of bank draft or Demand draft (No other modes will be entertained) drawn in favour of Block Development Officer, Ganjam in any Nationalized bank having its branch at Ganjam block area on any working day from **20.01.2025** to **05.02.2025** for the above works.
- 2. Date of receipt & Mode of submission of tender papers:** The detailed notification is available at official website (<http://www.ganjam.nic.in>) from **20.01.2025** & the bidders can also download the tender documents from the respective website on **20.01.2025**. The last date & time for receiver of bid is **05.02.2025** upto **5.00 pm** through Registered / Speed post only. **The tender must super scribe the name of the work/project on the sealed envelope.**

- 3. Date of opening of tender papers:** The tender paper shall be opened on **05.02.2025** at **5.30 PM** in the presence of bidders or their authorized representative having written authorization for the purpose & the members of the tender committee.
- 4. Earnest Money Deposit:** 1 % (One Percent) of the bid value in shape of NSC / Postal saving pass book / Post Office Time Deposit / Kishan Vikash Patra/Deposit receipt in schedule bank only, duly pledged in favour of **Block Development Officer, Ganjam**. The tender papers without required amount of E.M.D will not be considered & transfer or adjustment of E.M.D is also inadmissible.
- 5. Documents to be attached:** The following document should be furnished with the tender papers failing which the tender will be liable to rejection.
- (a) E.M.D pledged in favour of the Block Development Officer, Ganjam .
 - (b) Attested copy of contractor registration certificate.
 - (c) Attested copy of PAN Card & Certificate of GSTIN.

 - (f) The bidders have to produce an original affidavit in support of the authenticity of documents including EMD, etc attached with the tender papers.
 - (g) Affidavit as regards the facts of availing award of the work without submission of EMD/ISD during the current financial year in case of Engineer contractors desirous of availing exemption of EMD otherwise their tender paper will be liable for rejection.
 - (h) Joint venture consortium agreements are not allowed to participate in tender.
- 6.** Shortfall of any required document(s) & EMD, the tender paper will be liable for rejection.
- 7. Additional Performance Security Deposit:** The affidavit in lieu of APS will be submitted by the successful bidder for the cost of less quoted percentage of the amount put to tender before the signing of the agreement of the contract. (Vide Works Department Letter No-13286 date-07.09.2017, Govt. of Odisha, Works Department)
- 8. Forfeiture:** The EMD amount will be forfeited, if the bidders backs out from the offer acceptance of tender, by the competent authority.

1. Sealed tenders are invited from the registered Contractors of PWD/Irrigation/RWD of State Govt. C & B class contractors in prescribed form to be eventually drawn in P.W.D. form no.P-1 and will be received through registered/speed post only at o/o Block Development Officer, Ganjam up to 5.00 P.M. Dtd:- 5.2.2025 for the work "CONSTRUCTION OF GPLF BUILDING WITH MARKET COMPLEX AT POIRASI, GP-POIRASI UNDER GANJAM BLOCK" and will be opened before the tender committee in the presence of the tenderers or their authorized representatives at 5.30 P.M. on dated 5.2.2025. The amount of the estimate is approximately Rs. 23,74,487/- (Rupees Twenty three Lakhs seventy four thousand four hundred eighty seven) only.
2. The tenderers should please note that the work will have to be completed within Six Months commencing from the date of issue of work order. Tenderers are required to submit detail programme of works along with the tender which they consider necessary keeping in view of the clause 2 of the P.W.D. Form No.P-1. Without these programmes of works, the tender will be considered defective. Authority for acceptance of tenders would rest with Block Development Officer, Ganjam.
3. Tenderers are required to pay earnest money at 1% of the estimated amount i.e. Rs.23,745/- (Rupees Twenty three Thousand Seven Hundred forty five) only either in shape of Bank Draft/ N.S.C./ Postal Time Deposit Pass Book/ Deposit Receipt of Scheduled Bank duly pledged to the Block Development Officer, Ganjam otherwise their tender will not be considered.

The earnest money will be refunded to the unsuccessful tenderers on application as per the terms and conditions laid down in O.P.W.D. Code and the same will be retained in case of the successful tenderers and will not carry any interest.

4. (a) The plan & specification for the work can be seen at the office of the Block Development Officer, Ganjam during working hours and days. Complaints at a future date that the plan and specifications have not been seen, cannot be entertained. The contractor may obtain a set of tender documents for the work from the office of payment of Non-refundable fund Rs.6,000.00 (Rupees Six Thousand) only in shape of Demand Draft OR Bank Draft issued from any scheduled bank . The tender must be submitted in a sealed cover through registered/ speed post only. The name of the tenderer and the name of the work are to be super scribed on the cover.
- (b) All other information can be obtained on application to the Block Development Officer, Ganjam.

The authority will not be responsible if any portion of the tender document is modified and in all cases this conditions stipulated in the original document kept in the office of the undersigned shall prevail.

- (c) The intending tenders may remit the cost of the tender papers through postal money order. However, the organization will not be held responsible, if there is any delay in receipt of tender documents by the intending contractors sent by department through registered post and similarly the tender documents sent through registered / Speed post do

not reach in the Block Development Officer, Ganjam by the scheduled date and time, their offers will not be considered on any account even if the tender documents were dispatched by the tenderers before the due date. The cost of registration fees will be borne by the intending tenderers.

5. Block Development Officer, Ganjam reserves the right to reject any or all the tenders received without assigning any reasons thereof.
6. The tenderer whose tender is selected for acceptance shall within a period of seven days upon written information being given to him of acceptance of his tender make an initial security deposit @ 1% (One percent) of the tendered amount. So that the earnest money and initial security deposit will be 2% of the tendered amount as shown in clause 3 above and sign the agreement in the P.W.D. Form No.-P1 for due fulfillment of contract in the office of the Block Development Officer, Ganjam.

The security deposit, together with the earnest money and the amount withheld according to the provision of P1 agreement shall be retained as security deposit for the fulfillment of this contract. Failure to enter into the required agreement and to make the security deposit as above shall entail forfeiture of the earnest money. No tender shall be finally accepted until the required amount of security money is deposited. The written agreement to be entered into between the contractor and the Block Development Officer, Ganjam shall be foundation of rights of the parties and the contract shall be deemed to be incomplete until the agreement has first been signed by the contractor and then by the proper officer authorized to enter into the contract on behalf of the Government. The department will accept the security deposit in the form of N.S.C., N.D.C., Postal Time Deposit Pass Book duly pledged to Block Development Officer Ganjam and in no other form. In case of tenderers who have made fixed deposits, action will be taken to degrade them if they decline to sign the agreement within the period as in above case.

7. The rates should be quoted in words and figures and the units in words otherwise the tender will be liable for rejection. In case of discrepancy between words and figures, the words shall prevail and in case of discrepancy between unit rate and total, the unit rate shall prevail. The rates should be quoted in Rupees and Paisa, but not in Rupees and annas. The tender shall be written legibly and free from erasures, over writing's or conversation of figures. Corrections where unavoidable should be made by scoring out initialing dating and rewriting. The tender should also show total of each page and grand total of whole tender.
8. The contractors shall be responsible for payment of all royalties or other charges for quarrying materials. All local taxes inclusive of GST & Income Tax, Ferry & Tollage charges and Octroi Taxes are to be paid by Contractor.
9. The tender may not, at the discretion of the competent authority, be considered unless accompanied by attested copies of GST certificate, non-assessment certificate as the case may be and the original certificate produced before the Block Development Officer, Ganjam at the time of opening of the tender.



10. If the contractor removes any materials or stock so supplied to him from the site of work with a view of disposing of the same dishonestly, he should in addition to any other liabilities Civil or Criminal arising out of the contract be liable to pay a penalty equivalent to five times the price of the materials or stock according to the stipulated rates and the penalty to impose shall be recovered from any sum that may then or at any time there after become due to the contractor or from his security or from the proceeds of sales thereof.
11. The contractor should be fully liable to indemnify the department for payment of any compensation under "Workman" compensation Act. VII of 1023 on account of the workmen being employed by him and the full amount of compensation paid will be recovered from the contractor.
12. Every tenderer must examine the detailed specification of Orissa before submitting his tender. The rights is reserved without impairing the contract to make such increase in the quantities or items of work mentioned in the scheduled attached to the tender notice as may be considered necessary to complete the work fully and satisfactory. Such increase or decrease shall in no case invalidate the contract or rates. It shall be definitely understood that the Govt. do not accept any responsibility for the correctness or completeness of the quantities shown in the schedule. The schedule is liable to alteration by omission or additions or deduction and such omission deduction shall in no case invalidate the contract and no extra monetary compensation will be entertained.

Department will not supply any materials what so ever for the work. The tenderer shall be financially solvent and stable for advance procurement of all materials required for the work vide Government of Odisha Finance Department Memo No.-48443/ F Code- 46 / 95 dated 11.12.1995.

13. All reinforced cement concrete work should confirm to Orissa Detail standard specification & should be of grade M-15 and M-20 equivalent to nominal proportion 1:2:4 / 1:1.5:3 having minimum compressive strengthen in work test of 150 Kg/ Cm² / 200 Kg / Cm² in 15 Cm. cubes at 28 days after mixing and test conducted in accordance with IS-456 & 516 using 12mm. to 20mm. size hard black crusher broken granite chips. (20mm size not to exceed 25%)
14. Shuttering and centering shall be with seasoned Sal wood planks and the inside of which shall be lined suitable sheeting and made leak proof and water tight or alternatively steel shuttering and centering may be used.
15. For the purpose of jurisdiction in the event of dispute if any the contract should be deemed to have been entered into within the State of Odisha and it is agreed that neither partly to the contract at any place outside the State of Odisha.
16. Percentage rate contract (Vide works Department letter no-8310 Dt. 17.05.2006) in case of Percentage rate tender:-
 - i. The contractor has to quote percentage excess or less over the estimated cost in the price bid appended to the tender document.

ii. The contractors participated in the tender for more than one work may offer conditional rebate. Rebate offer submitted in a separate letter duly scanned shall be opened, declared & recorded first. The rebate so offered shall be considered after opening of all packages called in the same Tender Notice. The contractor who wish to tender for two or more works shall submit separate tender for each. Each tender shall have bid identification Number, Name & Sl. No of the work (As per IFB) to which they refer.

iii. The contractor will quote percentage excess/less up to one decimal point only. If he writes the percentage excess/less up to two or more decimal points, the first decimal point shall only be considered without rounding off.

iv. In the contract P-1 time is essence. The contractor is required to maintain a certain rate of progress specified in the contract.

v. The quantity mentioned can be increased or reduced to the extent of 10% for individual items subject to a maximum of 5% over the estimated cost. If it exceeds the limit stated above prior approval of competent authority is mandatory before making any payment.

vi. The period of completion is fixed & cannot be altered except in case of exceptional circumstances with due approval of next higher authority.

vii. Bills for percentage rate tenders shall be prepared at the estimated rates for individual items only & the percentage excess or less shall be added or subtracted from the gross amount of the bill.

17. After the work is finished all surplus materials and debris are to remove by the contractor and preliminary work such as vats, mixing platform etc. are to be dismantled and all the materials are to be removed from the site. The ground up to 15m wide from the building should be cleared and rough dressed. No extra payment will be made to the contractor on this account. The rate quoted should be inclusive of all these items.
18. The contractor shall not interface with the execution of water supply or electrical fittings arrangement and any other works entrusted to any other agency by the department at any time during the progress of the work.
19. The department will have the right to inspect the scaffolding and centering made for the work and can reject partly or fully such structures if found defective in their opinion.
20. The contractor will have to arrange for water supply for all works and make sanitary arrangements at this own cost for his labour camps. Contractor has to arrange adequate lighting arrangements for night work whenever necessary at his own cost.
21. Baling out water from the foundation either rainwater or sub-soil water if necessary should be borne by the contractor. No payment will be made for bench marks, level pillars profiles

and inching and leveling ground where required. The rates quoted should be for finished items of work inclusive of these incidental items of work.

22. All the quantities mentioned in the schedule are combined for ground floor and multi floors incase multistoried building the rates should be through for the same unless otherwise mentioned in the schedule of quantities for individuals items.
23. Cement concrete in roof slab beams etc. wherever prescribed by the Engineer in charge shall be machine mixed and vibrated and the contractor should arrange his own concrete mixers, vibrators and pumps etc. for the purpose.
24. It should be understood clearly that no claim what so ever will be entertained.
25. The tenderer shall have to abide by the CPWD safety code rule introduced by the Government of India Ministry of Works, housing and supply in their standing orders No. 44 to 50 dated 25.11.1957 which can be seen in the office of the Block Development Officer, Ganjam during working hours & days.
26. Tenders are required to abide by the fair wage clauses as introduced by the Government.
27. The contractor will be responsible for the loss or damage of any departmental materials equipments supplied to him under clauses 13, 30 and 32 during execution of the work due to reason whatsoever and cost of such materials will be recovered from him at prevailing stock issue rates plus storage charges or market rates whichever is higher.
28. The contractor should arrange at his own cost necessary tolls and plants machines concrete mixer & vibrators and other machineries such as pumps etc. required for the efficient execution of the work and rates quoted should be inclusive of the running charges of such plant and cost of consumable.
29. The contractor will have to submit to the Block Development Officer, Ganjam, monthly return of labour both skilled and unskilled employed by him on the work.
30. The tenderers are required to go through each clause of P.W.D. Form No.-P₁ carefully in addition to clauses mentioned herewith before tendering.
31. No part of the contract shall be sublet without written permission of Block Development Officer, Ganjam or transfer is made by power of attorney authorizing others to receive payment on the contractor's behalf.
32. No tender documents will be sold to the intending contractor after the last date stipulated for sale of tender paper.
33. If further necessary information is required Assistant Engineer, Ganjam Block will furnish such, but it must be clearly understood that the tenders must be received in order and according to the institutions.
34. Cement shall be used by bags and weight of cubic meter of cement being taken as 14.42qtl.

35. The following clauses have been revised /substituted as per works Department office memorandum No. 12366 Dtd. 08.11.2013. Details can be seen in the website: <http://tenderodisha.gov.in> .

- (i) Every bidder is expected before quoting his rate to inspect the site of proposed work. The bidder should also inspect the quarries & approach roads to quarries & satisfy himself/themselves about the quality & availability of materials. In every case of materials must comply with the relevant specifications. Complaints at future date that the availability of materials at quarries has been misjudged cannot be entertained

Amendment to Para. 3.4.16(a) (vii) of OPWD Code Vol.1 by substitutions

- (ii) For the purpose of estimate, the approved quarry lead is to be provided judiciously. Engineers in charge would be responsible for ensuring the quality of materials supplied. The contractors would, however be responsible for procurement of materials from authorized sources & voluntary disclose the source of procurement for the purpose of billing. Besides, the bidder would be required to submit the details of quarry for procurement while submitting the bids.
36. Government will not however after acceptance of contract rate pay any extra charges for lead or any other reason in case the contractor is found later on to have misjudged the materials available.
37. All fittings for doors and windows if supplied by the contractor should be of best quality and should be got approved by AEE/AE/JE Ganjam Block before they are used on the work.
38. The tender containing extraneous conditions not covered by the tender call notice are liable for rejection.
39. (a) The contractor shall have to furnish a certificate in the prescribed Performa enclosed herewith along the tender to effort that he is not related to any officers of Block Development Officer, Ganjam

(b) CERTIFICATE OF NO RELATIONSHIP

2. With a view to avoiding these situations Govt. have been pleased to decide that with effect from 01.04.96 there will neither purchase of department store materials nor booking of materials to show utilization of budget provision. It will be the responsibility of the contractor to purchase stores and utilize them in the work since materials like cement, steel etc. are easily and abundantly available at places, there will be no difficulty for contractors to procure the same. Therefore the future agreement with the contractors shall be executed accordingly and necessary modification to the agreement from may be made. In case where agreement have already been executed for department supply of materials, efforts should be made to fulfill the same by utilization to the existing stores and also through inter divisional and even inter department transfer of stores. For utilization of the surplus materials, agreements may however be made for supplying of materials to the extent available. In this way the existing materials should be exhausted.
3. Maintenance work should be undertaken by purchasing materials in case of departmental execution of work by directly charging to site account or through contractors. There should not be advance purchase of materials for the sake of storing and utilizing the same in future works.
4. Consequent upon introduction of the new system the Engineer-in-Charge of the work will have to exercise strict quality control and ensure that materials used by the contractors conform to the standard specifications

46. The contractor shall employ one or more Engineering Graduates or Diploma Engineers as apprentices at his own cost for works costing Rs.2.50 Lakhs or more. The apprentices will be selected by the Chief Engineer (R&B) Orissa. The stipend to be paid to the apprentices

should not be less than Rs.200 and Rs.150 per month in case of Graduate Engineer, Diploma, holder engineers respectively. The period of employment will commencement within one months of the date of issue of work order and would last till the date when 90% of work is completed. Number of apprentices employed should be fixed by Chief Engineer in any manner so that the total expenditure does not exceed 1% of the tendered cost of the work (vide works & Transport Department, Letter No.-17331, Dt.-12.08.1966).

47. The tenderer shall bear cost of various incidental sundries and contingencies necessitated by the work falling within following or similar category.

 - (f) Suitable fencing barriers signals including paraffin and electrical signal where necessary at works and approaches in order to protect the public and employees from accidents.
 - (g) Compensation including cost of any suit for injury to persons or property due to neglect of any major precautions also sums which may become payable due to operation or Workmen's compensation Act.
 - (h) The contractor has to arrange adequate lighting arrangements for night works wherever necessary at his own cost.
 - (i) The contractor has to arrange all the building materials including the equipments required for under reamed pile foundation for starting the work.
48. The prevailing percentage of I.T Department of the gross amount of the bill & surcharge as applicable will be deducted from the contractor's bill towards income tax.
49. The prevailing of GST on the gross amount of the bill will be deducted from the contractor's bill.
50. Under section 12 of the Contract labour regulation & abolition Act 1970, the contractor who undertakes execution of work through labour should produce valid license from licensing authority of labour department.

51. The KB brick should be well burnt and of good qualities. The brick should be approved by the Engineer-in-Charge before use in the work and should confirm the minimum strength as per national building code.
52. When department machinery will be utilized in the work by the contractors necessary and prevailing hire charges as fixed by the departments will be recovered from the contractor who may see the hire charges of the machinery in the office of the Block Development Officer, Ganjam.



(B) Amendment to Para 3.5.5 (V) of Note-III of OPWD Code Vol-I by modification.

For availing Incentive Clause in any project which is completed before the stipulated date of completion, subject to other stipulations it is mandatory on the part of the Block Development Officer, Digapahandi to report the actual date of completion of the project so that the report is received within 7 (seven) days of such completion by the Zilla Parishad, Ganjam.

The incentive for timely completion should be on a graduated scale of 1 (one) percent to 5 (five) percent of the contract value. Assessment of incentives may be worked out for earlier completion of work in all respect in the following scale.

Before 30% of contract period = 5% of Contract Value

If the contractor removes any materials or stock so supplied to him from the site of work with a view of disposing of the same dishonestly, he should in addition to any other liabilities Civil or Criminal arising out of the contract be liable to pay a penalty equivalent to five times the price of the materials or stock according to the stipulated rates and the penalty to impose shall be recovered from any sum that may then or at any time there after become due to the contractor or from his security or from the proceeds of sales thereof.


10. If the contractor removes any materials or stock so supplied to him from the site of work with a view of disposing of the same dishonestly, he should in addition to any other liabilities Civil or Criminal arising out of the contract be liable to pay a penalty equivalent to five times the price of the materials or stock according to the stipulated rates and the penalty to impose shall be recovered from any sum that may then or at any time there after become due to the contractor or from his security or from the proceeds of sales thereof.





1. Sealed tenders are invited from the registered Contractors of PWD/Irrigation/RWD of State Govt. C & B class contractors in prescribed form to be eventually drawn in P.W.D. form no.P-1 and will be received through registered/speed post only at o/o Block Development Officer, Ganjam up to **5.00 P.M.** Dtd:- **5.2.2025** for the work "**CONSTRUCTION OF GPLF BUILDING WITH MARKET COMPLEX AT KHANDADEULI, GP-KHANDADEULI UNDER GANJAM BLOCK**" and will be opened before the tender committee in the presence of the tenderers or their authorized representatives at **5.30 P.M.** on dated **5.2.2025**. The amount of the estimate is approximately **Rs. 23,80,877/- (Rupees Twenty three Lakhs Eighty thousand Eight hundred seventy seven)** only.
2. The tenderers should please note that the work will have to be completed within **Six Months** commencing from the date of issue of work order. Tenderers are required to submit detail programme of works along with the tender which they consider necessary keeping in view of the clause 2 of the P.W.D. Form No.P-1. Without these programmes of works, the tender will be considered defective. Authority for acceptance of tenders would rest with Block Development Officer, Ganjam.
3. Tenderers are required to pay earnest money at **1%** of the estimated amount i.e. **Rs.23,809/- (Rupees Twenty three Thousand eight Hundred nine)** only either in shape of Bank Draft/ N.S.C./ Postal Time Deposit Pass Book/ Deposit Receipt of Scheduled Bank duly pledged to the Block Development Officer, Ganjam otherwise their tender will not be considered.

The earnest money will be refunded to the unsuccessful tenderers on application as per the terms and conditions laid down in O.P.W.D. Code and the same will be retained in case of the successful tenderers and will not carry any interest.

4. (a) The plan & specification for the work can be seen at the office of the Block Development Officer, Ganjam during working hours and days. Complaints at a future date that the plan and specifications have not been seen, cannot be entertained. The contractor may obtain a set of tender documents for the work from the office of payment of Non-refundable fund **Rs.6,000.00 (Rupees Six Thousand)** only in shape of Demand Draft OR Bank Draft issued from any scheduled bank . The tender must be submitted in a sealed cover through registered/ speed post only. The name of the tenderer and the name of the work are to be super scribed on the cover.
- (b) All other information can be obtained on application to the Block Development Officer, Ganjam.

The authority will not be responsible if any portion of the tender document is modified and in all cases this conditions stipulated in the original document kept in the office of the undersigned shall prevail.

- (c) The intending tenders may remit the cost of the tender papers through postal money order. However, the organization will not be held responsible, if there is any delay in receipt of tender documents by the intending contractors sent by department through registered post and similarly the tender documents sent through registered / Speed post do

not reach in the Block Development Officer, Ganjam by the scheduled date and time, their offers will not be considered on any account even if the tender documents were dispatched by the tenderers before the due date. The cost of registration fees will be borne by the intending tenderers.

5. Block Development Officer, Ganjam reserves the right to reject any or all the tenders received without assigning any reasons thereof.
6. The tenderer whose tender is selected for acceptance shall within a period of seven days upon written information being given to him of acceptance of his tender make an initial security deposit @ 1% (One percent) of the tendered amount. So that the earnest money and initial security deposit will be 2% of the tendered amount as shown in clause 3 above and sign the agreement in the P.W.D. Form No.-P1 for due fulfillment of contract in the office of the Block Development Officer, Ganjam.

The security deposit, together with the earnest money and the amount withheld according to the provision of P1 agreement shall be retained as security deposit for the fulfillment of this contract. Failure to enter into the required agreement and to make the security deposit as above shall entail forfeiture of the earnest money. No tender shall be finally accepted until the required amount of security money is deposited. The written agreement to be entered into between the contractor and the Block Development Officer, Ganjam shall be foundation of rights of the parties and the contract shall be deemed to be incomplete until the agreement has first been signed by the contractor and then by the proper officer authorized to enter into the contract on behalf of the Government. The department will accept the security deposit in the form of N.S.C., N.D.C., Postal Time Deposit Pass Book duly pledged to Block Development Officer Ganjam and in no other form. In case of tenderers who have made fixed deposits, action will be taken to degrade them if they decline to sign the agreement within the period as in above case.

7. The rates should be quoted in words and figures and the units in words otherwise the tender will be liable for rejection. In case of discrepancy between words and figures, the words shall prevail and in case of discrepancy between unit rate and total, the unit rate shall prevail. The rates should be quoted in Rupees and Paisa, but not in Rupees and annas. The tender shall be written legibly and free from erasures, over writing's or conversation of figures. Corrections where unavoidable should be made by scoring out initialing dating and rewriting. The tender should also show total of each page and grand total of whole tender.
8. The contractors shall be responsible for payment of all royalties or other charges for quarrying materials. All local taxes inclusive of GST & Income Tax, Ferry & Tollage charges and Octroi Taxes are to be paid by Contractor.
9. The tender may not, at the discretion of the competent authority, be considered unless accompanied by attested copies of GST certificate, non-assessment certificate as the case may be and the original certificate produced before the Block Development Officer, Ganjam at the time of opening of the tender.

10. If the contractor removes any materials or stock so supplied to him from the site of work with a view of disposing of the same dishonestly, he should in addition to any other liabilities Civil or Criminal arising out of the contract be liable to pay a penalty equivalent to five times the price of the materials or stock according to the stipulated rates and the penalty to impose shall be recovered from any sum that may then or at any time there after become due to the contractor or from his security or from the proceeds of sales thereof.
11. The contractor should be fully liable to indemnify the department for payment of any compensation under "Workman" compensation Act. VII of 1023 on account of the workmen being employed by him and the full amount of compensation paid will be recovered from the contractor.
12. Every tenderer must examine the detailed specification of Orissa before submitting his tender. The rights is reserved without impairing the contract to make such increase in the quantities or items of work mentioned in the scheduled attached to the tender notice as may be considered necessary to complete the work fully and satisfactory. Such increase or decrease shall in no case invalidate the contract or rates. It shall be definitely understood that the Govt. do not accept any responsibility for the correctness or completeness of the quantities shown in the schedule. The schedule is liable to alteration by omission or additions or deduction and such omission deduction shall in no case invalidate the contract and no extra monetary compensation will be entertained.

Department will not supply any materials what so ever for the work. The tenderer shall be financially solvent and stable for advance procurement of all materials required for the work vide Government of Odisha Finance Department Memo No.-48443/ F Code- 46 / 95 dated 11.12.1995.

13. All reinforced cement concrete work should confirm to Orissa Detail standard specification & should be of grade M-15 and M-20 equivalent to nominal proportion 1:2:4 / 1:1.5:3 having minimum compressive strengthen in work test of 150 Kg/ Cm² / 200 Kg / Cm² in 15 Cm. cubes at 28 days after mixing and test conducted in accordance with IS-456 & 516 using 12mm. to 20mm. size hard black crusher broken granite chips. (20mm size not to exceed 25%)
14. Shuttering and centering shall be with seasoned Sal wood planks and the inside of which shall be lined suitable sheeting and made leak proof and water tight or alternatively steel shuttering and centering may be used.
15. For the purpose of jurisdiction in the event of dispute if any the contract should be deemed to have been entered into within the State of Odisha and it is agreed that neither partly to the contract at any place outside the State of Odisha.
16. Percentage rate contract (Vide works Department letter no-8310 Dt. 17.05.2006) in case of Percentage rate tender:-

ii. The contractors participated in the tender for more than one work may offer conditional rebate. Rebate offer submitted in a separate letter duly scanned shall be opened, declared & recorded first. The rebate so offered shall be considered after opening of all packages called in the same Tender Notice. The contractor who wish to tender for two or more works shall submit separate tender for each. Each tender shall have bid identification Number, Name & Sl. No of the work (As per IFB) to which they refer.

iii. The contractor will quote percentage excess/less up to one decimal point only. If he writes the percentage excess/less up to two or more decimal points, the first decimal point shall only be considered without rounding off.

iv. In the contract P-1 time is essence. The contractor is required to maintain a certain rate of progress specified in the contract.

v. The quantity mentioned can be increased or reduced to the extent of 10% for individual items subject to a maximum of 5% over the estimated cost. If it exceeds the limit stated above prior approval of competent authority is mandatory before making any payment.

vi. The period of completion is fixed & cannot be altered except in case of exceptional circumstances with due approval of next higher authority.

vii. Bills for percentage rate tenders shall be prepared at the estimated rates for individual items only & the percentage excess or less shall be added or subtracted from the gross amount of the bill.

17. After the work is finished all surplus materials and debris are to remove by the contractor and preliminary work such as vats, mixing platform etc. are to the dismantled and all the materials are to be removed from the site. The ground up to 15m wide from the building should be cleared and rough dressed. No extra payment will be made to the contractor on this account. The rate quoted should be inclusive of all these items.
18. The contractor shall not interface with the execution of water supply or electrical fittings arrangement and any other works entrusted to any other agency by the department at any time during the progress of the work.
19. The department will have the right to inspect the scaffolding and centering made for the work and can reject partly or fully such structures if found defective in their opinion.
20. The contractor will have to arrange for water supply for all works and make sanitary arrangements at this own cost for his labour camps. Contractor has to arrange adequate lighting arrangements for night work whenever necessary at his own cost.
21. Baling out water from the foundation either rainwater or sub-soil water if necessary should be borne by the contractor. No payment will be made for bench marks, level pillars profiles

and inching and leveling ground where required. The rates quoted should be for finished items of work inclusive of these incidental items of work.

22. All the quantities mentioned in the schedule are combined for ground floor and multi floors incase multistoried building the rates should be through for the same unless otherwise mentioned in the schedule of quantities for individuals items.
23. Cement concrete in roof slab beams etc. wherever prescribed by the Engineer in charge shall be machine mixed and vibrated and the contractor should arrange his own concrete mixers, vibrators and pumps etc. for the purpose.
24. It should be understood clearly that no claim what so ever will be entertained.
25. The tenderer shall have to abide by the CPWD safety code rule introduced by the Government of India Ministry of Works, housing and supply in their standing orders No. 44 to 50 dated 25.11.1957 which can be seen in the office of the Block Development Officer, Ganjam during working hours & days.

27. 29. The contractor will have to submit to the Block Development Officer, Ganjam, monthly return of labour both skilled and unskilled employed by him on the work.
