4. The Tender shall be accompanied by EMD for an amount as stipulated above for each work in shape of NSC/Postal Saving Pass Book/ Post Office Time Deposit/ Kishan Vikash Patra/ Deposit receipt in

Schedule Bank only. Duly pledged in favour of Block Development Officer, Kukudakhandi attested copies of valid ITCC/ PAN Card/GST Clearance Certificate/Valid license, without which the tender is liable for rejection. The tenderer shall furnish an affidavit at the time of submission of tender paper about the authentication of tender document.

5. The tender shall be received in a sealed cover through registered/ speed post only, to the above office in all working days during office hour up to 06.02.2025. The tender will be opened of the BDO, Kukudakhandi on 07.02.2025 at 11.00 AM in presence of tender or their authorized representative. If any of the above dates will be declared as the Govt holiday then the next working day shall be considered for sale of tender paper, receipt and opening of the tender respectively.
6. The tender will be received in the Office of the BDO, Kukudakhandi, Ganjam within the stipulated date and time by registered post /Speed Post. The tender shall be submit the required documents in a sealed cover subscribed with the name of Work only and it shall be ensure that the name of firms /bidder shall not be written anywhere on the sealed cover.
7. The tender received after due date and time shall not be entertain and the authority shall not held responsible for delay / missing of tender during postal or courier transit.
8. Any bidder went out from the office before acceptance of the tender, the EMD along with the other deposit, deposited by him will be forfeited.
9. Engineering contractors during intending to avail the exemption facility of EMD should apply specifically their application with an affidavit and submit the same with tender documents. He should also produce original contract license at the time of opening of tender document to make necessary entry to that affect as such facilities are limited to their participation in the tender during a financial year, otherwise the tender will be rejected on the spot during opening of the tender.
10. The affidavit in lieu of APS will be submitted by the successful bidder for the cost of less quoted in percentage of the amount put to tender before the signing of the agreement of the (vide Work Department L.No.13286 Date.07/09/2017, Govt. of Odisha).
