- 2. Sale of Tender Papers:** The tender document will be sold from **06.03.2025 to 18.03.2025** at Block Office Sanakhemundi between **10:00AM to 5:00PM** on working days only.
- 3. Date of receipt & Mode of submission of tender papers:** The bidders have to submit the sealed tender papers in complete shape through Registered Post/Speed Post/Tender Box (Available at Block Office) to be directly sending it to the Block Development Officer, Sanakhemundi. The last date of receipt of tender paper **21.03.2025 up to 05:00PM**. The undersigned will not be responsible for postal delay if any or non receipt of papers in time. **The tender must super scribe the name of the work/project on the sealed envelope.**

4. **Date of opening of tender papers:** The tender paper shall be opened on 24.03.2025 at 11:00 AM in the presence of bidders or their authorized representative having written authorization for the purpose & the members of the tender committee.
5. **Earnest Money Deposit:** 1 % (One Percent) of the bid value in shape of NSC / Postal saving pass book / Post Office Time Deposit / KishanVikashPatra/Deposit receipt in schedule bank only, dulypledged in favour of Block Development Officer, Sanakhemundi. The tender papers without required amount of E.M.D will not be considered & transfer or adjustment of E.M.D is also inadmissible.
6. **Documents to be attached:** The following document should be furnished with the tender papers failing which the tender will be liable to rejection.
- E.M.D pledged in favour of the Block Development Officer, Sanakhemundi .
 - Attested copy of contractor registration certificate.
 - Attested copy of PAN Card & Certificate of GSTIN.
 - Original money receipt granted by BDO, Sanakhemundi towards cost of tender paper.
 - Attested copy of Caste certificate issued by competent authority in case of SC/ST Contractor desirous of availing preference.
 - The bidders have to produce an original affidavit in support of the authenticity of documents including EMD, etc attached with the tender papers.
 - Affidavit as regards the facts of availing award of the work without submission of EMD/ISD during the current financial year in case of Engineer contractors desirous of availing exemption of EMD otherwise their tender paper will be liable for rejection.
 - Joint venture consortium agreements are not allowed to participate in tender.
7. Shortfall of any required document(s) & EMD, the tender paper will be liable for rejection.
8. **Additional Performance Security Deposit:** The affidavit in lieu of APS will be submitted by the successful bidder for the cost of less quoted percentage of the amount put to tender before the signing of the agreement of the contract. (Vide Works Department letter No-13286 date-07.09.2017, Govt. of Odisha, Works Department)
9. **Forfeiture:** The EMD amount will be forfeited, if the bidders backs out from the offer acceptance of tender, by the competent authority.
10. Submission of more than one tender paper by a bidder for a single work will be liable for rejection of all such tender papers.




