- 1. Cost of Tender paper :** The Tender paper & specifications can be obtained from the official website of Ganjam i.e. www.ganjam.nic.in.
- 2. Date of receipt and mode of submission of Tender papers :** The Tenderers have to submit the sealed tender papers in complete shape through **Registered Post/Speed post only**, in the addressed to the B.D.O, Patrapur. The last date of receipt of tender papers is **21-03-2025 up to 5.00 P.M.** The undersigned will not be responsible for postal delay if any or non receipt of the papers in time. **The tenders must super scribe the name of the work/project on the sealed envelope.**
- 3. Date of Opening of Tender Paper:** The tender paper shall be opened on **24.03.2025 at 11.00 A.M** in the presence of the tenderers or their authorized representative having written authorization for the purpose and the members of tender committee.
- 4. Earnest Money Deposit :** 1%(one percent) of the bid value in shape of post office Term Deposit / Short Term Deposit/N.S.C/K.V.P/Deposit Receipt of any Nationalized bank duly pledged in favour of Block Development Officer, Patrapur. The Tender papers without required amount of E.M.D. will not be considered and transfer or adjustment of E.M.D is also inadmissible.
- 5. Documents to be attached:** The following documents should be furnished with the tender papers failing which the tender will be liable to rejection.
 - (a) E.M.D. pledged in favour of the Block Development Officer, Patrapur.
 - (b) Cost of tender paper in shape of B.D in favour of the B.D.O., Patrapur
 - (c) Attested copy of Contractor Registration Certificate.
 - (d) Attested copy of PAN card and Certificate of GSTIN.
 - (e) Attested copy of caste certificate issued by competent authorities in case of SC/ST contractors desirous of availing preference.

(f) The bidders have to produce an original affidavit in support of the authenticity of documents etc attached with the tender papers.

(g) Affidavit as regards the facts of availing award of work without submission of EMD/ISD during the current financial year in case of Engineer Contractors desirous of availing exemption of EMD otherwise their tender paper will be liable for rejection.

(h) Joint venture consortium agreements are not allowed to participate in tender.

6. Shortfall of any required document(s) and EMD, the tender paper will be liable for rejection.

7. **Additional Performance Security Deposit** : The affidavit in lieu of APS will be submitted by the successful bidder for the cost of less quoted in percentage of the amount put to tender before the signing of the agreement of the contract. (Vide Works Department Letter No.-13286 Date-07/09/2017, Govt. of Odisha, Works Department.)

8. **Forfeiture**: The EMD amount will be forfeited, if the tenderer backs out from the offer acceptance of tender, by the competent authority.

9. Submission of more than one tender paper by a bidder for a single work will be liable for rejection of all such tender papers.

10. The Block Development Officer, Patrapur reserves the right to reject any or all the tenders without assigning any reasons thereof. Other details can be seen in the bidding documents.
