Sub: Cancellation of Tender Call Notice No.04/2024-25 dtd.20.03.2025 of BDO, Chikiti because of no successful bidder (L-1) during the tender Procedure.

OFFICE ORDER

As per Rule No.13 of OPWD code Vol-II and this office tender call notice no.1171 dtd.20.03.2025 of sl no.05 of Term and condition, a participant/bidder in the tender procedure has to submit the 01.00 % of Tender amount as EMD and duly pledged in favour of "Block Development Officer, Chikiti".

Only two bidders participated in each projects against the above Tender Call notice.

01. Sri Tirumaya Panigrahy, C Class Contractor of Village Nua Maisanpur of Kalabada GP has submitted an EMD in shape of DD but not pledged in favour of BDO, Chikiti resulting disqualification/rejection of tender of Sri Panigrahy.

02. Sri G Durjadhan Reddy, C-Class Contractor of Village Badapalanka of R Ch Pur, the other bidder has mentioned the quoted value with less of - 07.00% but the same has not been mentioned in the exact column of tender paper resulting disqualification/rejection at Technical bid stage of Sri Reddy.
