(Non-Refundable) in shape Bank draft or Demand draft (No other modes will be entertained) drawn in favour of Block Development Officer, Surada in any nationalized bank having its branch at Surada Block area on any working day from 03.05.2025 to 17.05.2025 (Working day 7.00A.M to 1.00 P.M) for the above works.
- Date of receipt & Mode of submission of tender papers:** The detailed notification is available at official website (<http://www.ganjam.nic.in>) from 03.05.2025 & the bidders can also download the tender documents from the respective website from 03.05.2025. The last date & time for receiving of bid is 17.05.2025 up to 5.00 pm through Registered/ speed post only. The tender must super scribe the name the work/project on the sealed envelope.
- Date of opening of tender papers:** The tender paper shall be opened on 20.05.2025 at 10.00 AM in the office chamber of BDO Surada in the presence of bidders or their authorized representative having written authorization for the purpose & the members of the tender committee.
- Earnest Money Deposit:** 1% (One Percent) of the work value in shape of NSC/TDR/Kissan Vikash Patra/pledged to BDO Surada enclosed with the tender papers. Without E.M.D the Tender will not be considered & transfer or adjustment of E.M.D is also not admissible except SC/ST/Engineering Contractor.
- Documents to be attached:** The following document should be furnished with the tender papers failing which the tender will be liable for rejection.
 - E.M.D pledged in favour of Block Development officer, Surada.
 - Attested copy of contractor registration certificate.
 - Attested copy of PAN card & Certificated of GSTIN.
 - Original money receipt issued by BDO, Surada toward cost of tender paper.
 - Attested copy of Cast certificate issued by the competent authority in case of SC/ST contractor for exemption of EMD.
 - The bidders have to produce an original affidavit in support of the authenticity of the documents including EMD, etc attached with the tender papers.
 - Affidavit/required certificate as regards the facts of availing award of the work without submission of EMD/ ISD during the current financial year in case of Engineer contractors desirous to avail exemption of EMD. Otherwise their tender paper will be liable for rejection.
 - Joint venture consortium agreements are not allowed to participate in tender.
- Shortfall of any required documents(s) & EMD,** the tender paper will be liable for rejection.
- Additional performance Security Deposit:** The affidavit in lieu of APSD will be submitted by the successful bidder for the cost of less quoted percentage of the amount put to tender before the signing of the agreement of the contract. 8. Forfeiture: The EMD amount will be forfeited, if the bidders back out from the offer acceptance of tender by the competent authority.

9. Submission of more than one tender paper by a bidder for a single work will be liable for rejection of all such tender papers.
