

Terms and Conditions

1. The Tender is to be super scribed with the name of the work and the item of work tendered for.
2. The intending purchasers are not required to produce any documents, viz, copy of Registration, valid GST clearance certificate, etc., at the time of purchase of tender documents.
3. Registered Contractor of Class C & B can obtain tender documents for the work either from Office of the Panchayat Samiti, Rangeilunda or from the official web site (<http://www.ganjam.nic.in>) in all working days during office hours from 23.05.2025 to 13.06.2025 on payment of the Cost as indicated in the table in shape of cash/A/c payee DD (Non-refundable) drawn in favour of Block Development Officer, Rangeilunda.
4. The Tender shall be accompanied by EMD for an amount as stipulated above for each work in the form of NSC/Postal Saving Pass Book/ Post Office Time Deposit/ Kishan Vikash Patra/ Deposit receipt in Schedule Bank only. Duly

pledged in favour of Block Development Officer, Rangeilunda attested copies of valid ITCC/ PAN Card/GST Clearance Certificate/Valid license, without which the tender is liable for rejection. The tenderer shall furnish an affidavit at the time of submission of the tender paper about the authentication of the tender document.

5. The tender shall be received in a sealed cover through registered/ speed post only, in the above office on all working days during office hours up to 13.06.2025, except on holidays. The tender will be opened by the BDO, Rangeilunda, on 16.06.2025 at 03.00 PM in the presence of the tenderer or their authorized representative. If any of the above dates are declared as the Govt holiday, then the next working day shall be considered for the sale of tender paper, receipt, and opening of the tender, respectively.
6. The tender will be received in the Office of the BDO, Rangeilunda, Ganjam, within the stipulated date and time by registered post /Speed Post. The tender shall be submitted with the required documents in a sealed cover subscribed with the name of the Work only, and it shall be ensured that the name of the firm/bidder shall not be written anywhere on the sealed cover.
7. Tenders received after the due date and time shall not be considered, and the authority shall not be held responsible for delays or missing tenders during postal or courier transit.
8. Any bidder who backs out of the office before acceptance of the tender, the EMD, along with the other deposit, deposited by him, will be forfeited.
9. Engineering contractors intending to avail the exemption facility of EMD should apply specifically for their application with an affidavit and submit the same with the tender documents. He should also produce an original contract license at the time of opening of the tender document to make necessary entry to that effect, as such facilities are limited to their participation in the tender during a financial year, otherwise, the tender will be rejected on the spot during the opening of the tender.
10. Conditional tenders shall be outrightly rejected. The authority reserves the right to reject any or all tenders without assigning any reason thereof.
11. No telegraphic / fax tender shall be entitled.
12. The tender paper received without the signature of the Contractor/agency will not be entertained.
