Duly pledged in favour of Block Development Officer, Digapahandi attested copies of valid ITCC/ PAN Card/GST Clearance Certificate/Valid license.
5. The tenderer shall Rejection. The tenderer shall furnish an affidavit at the time of submission of tender paper about the authentication of tender document.

The tender shall be received in a sealed cover through registered/ speed post only, to the above office in all working days during office hour up to **09.07.2025**.The tender will be opened of the BDO, Digapahandi on **10.07.2025** at **11.00** AM in presence of tender or their authorized representative. If any of the above dates will be declared as the Govt holiday then the next working day shall be considered for opening of the tender respectively.
7. The tender will be received in the Office of the BDO, Digapahandi, Ganjam within the stipulated date and time by registered post /Speed Post. The tender shall be submit the required documents in a sealed cover subscribed with the name of Work only and it shall be ensure that the name of firms /bidder shall not be written anywhere on the sealed cover.
8. Any bidder if went out from the office during the acceptance of the tender, the EMD along with the other deposit, deposited by him will be forfeited.
