


The chairperson initiation the discussion stated on the aims and objectives for convincing the meeting regarding rake handling of different Manufacturers at Jagannathpur branch of MARKFED. A threadbare discussion was held on the correspondence of R.C.S (o) communicated vide letter No. 19982 dt- 15.11.2018 and 22870 dt- 24.12.2018 regarding rake handling of the fertilizer and letter No. 2674 dt- 16.07.2025 of the Secretary, MARKFED-ODISHA, Bhubaneswar & Ltr. No- 111 dt- 19.07.2025 of Area Manager, MARKFED-ODISHA, Jagannathpur regarding model tender documents for appointment of rake handling contractor. Supply of Urea fertilizer by IFFCO is not sufficient to meet the requirement of the farmers. Hence MARKFED has decided to handle the rake of all Manufacturers during next 24 (twenty-four Months).






Further it was also decided in the meeting that, the advertisement should be mentioned with submission of all documents as per tender notice is mandatory.


The meeting ended with vote of thanks to the chair and participants.


