

- 2.Past Experience in same field. (Go ahead will be given depending upon nos of work orders(past experience) in the same field previously allotted to the firm.
- 3.Copy of Driving Licence of the Driver & RC.(to be enclosed)
- 4.Declaration that the Agency has not been declared as a Black listed ( to be enclosed)
- 5.The vehicle must be in a road worthy condition.
- 6.The vehicle should cover each GP's of the Block.
- 7.Successfull completion certificate to be obtained from BAO of the Block while submission of final output.
