Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender as Bid security.

8. Bids received off-line shall be **opened at 11.00 AM on 11/12/2025** in the office of the RMC Bhanjanagar, in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bid. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
