INVITATIONS FOR BIDS (IFB)

1. The Block Development Officer, Rangeilunda on behalf of Governor of Odisha invites Percentage Rate bids in Single Cover System in online mode for the works as detailed in the table, from the class of eligible contractors as mentioned in column-5 (Five) registered with the state Governments and contractors of equivalent Grade / Class registered with Central Government / MES / Railways for execution of Building works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. The successful bidder who has not registered under state Government has to register under the state PWD in appropriate class of eligibility before signing of the agreement.
2. The bidders may submit bids for the following works.

3. Bid documents consisting of specification, the schedule of quantities and the set of terms & conditions of contract and other necessary Documents can be seen in the website www.tendersodisha.gov.in.

4. i) The bidder shall transfer online the Earnest Money deposit/Bid Security of the amount specified for the work in the table col.4 above as part of its bid through a process as mentioned under DTCN.
ii) Only the successful Bidder who has quoted less bid price / rates than the estimated cost put to tender shall have to furnish as Additional Performance Security in shape of Term Deposit Receipt pledged in favour of the Block Development officer, Rangeilunda / from any nationalised schedule bank in India counter guaranteed by its local branch at Bhubaneswar within seven days as per Office Memorandum - 4559/W dt. 05.04.2021 of Works Department otherwise the bid shall be cancelled and further proceeding for blacklisting shall be initiated against bidder.

5. The Bid documents will be available in the website www.tendersodisha.gov.in from 10.00 Hours of 07.01.2026 to 17.00 Hours of 29.01.2026.

6. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class II or Class III.

7. Bids shall be received only "On-line" on or before 17.00 Hours of 29.01.2026.

8. The Cover-I (Technical Bid) of Single Cover shall be opened at 11.00 Hours on 30.01.2026 in the office of the Block Development officer, Rangeilunda in the presence of bidders who wish to attend.

Bidders who has participated in the bid can witness the opening of bids after log in on to the site through their DSC. If it happens to be a holiday the same will be opened in the next working days at the same time and venue. The Price Bid (Cover-II) of bidders who will be qualified in the Technical Bid shall be opened. The date, time & venue of opening of Price bid will be intimated later on.

9. The bidder shall transfer online the cost of bid document for vide column No. 6 towards cost of the Bid through a process as mentioned under DTCN.

10. Other details can be seen in the bid documents.

11. The authority reserves right to cancel any or all bids without assigning any reason thereof.

12. The Addendum/ Corrigendum if any will be hosted in the website only.

13. The ST/SC contractor shall be exempted from depositing EMD 50% of the usual rate i.e. 1% of estimated cost.

14. The ST/SC contractor can avail price preference of 10% on production of affidavit.

15. The authority will not be held responsible for any technical problem/ failure of network and server during the schedule dates of online Bidding.

16. The bidder shall deposit 1% EMD On-line mode & 1% of the tender amount at the time of signing of agreement.

17. EMD shall be exempted for Engineer contractors for three works in a financial year.

18. The price bids of those bidders who are qualified in the technical bid will only be opened.

19. The 1st lowest bidder must produce the original documents within the stipulated time period failing which action shall be taken to blacklist the Agency.

20. If the Contractor fails to complete the work, the amount so furnished as additional performance security will be forfeited & other penal action will be initiated.

21. If any intending bidders wish to withdraw from participation in the bid, He/she can freely withdraw from the participation before scheduled date and time of closure, In case the 1st lowest Bidder or even the next lowest Bidder withdraw in series one by one, in later stage thereby facilitating a particular Bidder for award, then they shall be penalized with adequate disincentives with forfeiture of EMD/Bid Security unless adequate justification for such back out is furnished. Appropriate action for blacklisting the bidder shall also be taken apart from disincentivizing the bidder.

22. The Authority reserves the right to reject any or all the tenders without assigning any reason thereof.

DTCN for each work, consisting of Schedule of Quantities, a set of Terms and Conditions and other necessary information are available in the website, <https://tendersodisha.gov.in>. Intending bidders are sincerely requested to go through the DTCN of the respective Work for which they intend to bid. The bids should be submitted only through on-line through the Website: <https://tendersodisha.gov.in> by the intending and eligible bidders.
