

**[3]. EXPERIENCE, QUALIFICATION, AGE AND CRITERIA FOR THE CHAIRPERSON AND MEMBER OF THE CWC:**

The eligibility criteria for selection of Chairperson and Members of the CWC shall now be governed by the provisions of the **Juvenile Justice (Care and Protection of Children) Model Rules, 2016 as amended in 2022**, and the Odisha Juvenile Justice (Care and Protection of Children) Rules, 2018.

For appointment as Chairperson or Member of the Committee, the applicant should have been:

1. The Chairperson and the members shall be above the age of thirty-five years and not more than sixty five years as on 01.01.2026 and shall have a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children and has been actively involved in health, education or welfare activities pertaining to children for seven years or is a practicing professional with a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children.
2. A member of the Committee shall be eligible for appointment of maximum of two terms, which shall not be continuous. "Provided that nothing contained in this sub-rule shall be a bar in case of a member being appointed as Chairperson".
3. The person applying for the post of the Chairperson or member of the Committee shall submit an affidavit, as per Form 49, certifying that the applicant is not barred by any of the conditions laid down in sub section 4A of section 27 of the Act.

4. A person associated with an organisation receiving foreign contribution shall not be eligible to be a Chairperson or member of the Committee.
5. Any person working in the implementation of the Act in any Non-Government Organisation or any organisation, performing such functions which may cause conflict of interest in discharge of their duties as the Chairperson or member of the Committee shall not be eligible for appointment as the Chairperson and member of the Committee.

**Explanation:** For the removal of doubt, it is hereby clarified that, this may include but is not limited to any of the following situations within the territorial jurisdiction of the Committee:

- (a) any family member is a member of any non-governmental organisation;
  - (b) close relation is a member of any non-governmental organisation ;
  - (c) cases of non-governmental organisations or persons working in a district for rescue and rehabilitation;
  - (d) a person representing a person who runs a Child Care Institution or member of the Board or Trust of any non-governmental organisation.
6. A member selected by the Selection Committee should not:
    - (i) has any past record of violation of human rights or child rights,
    - (ii) has been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offence,
    - (iii) has been removed or dismissed from service of the Government of India or State Government or an undertaking or corporation owned or controlled by the Government of India or State Government,
    - (iv) has ever indulged in child abuse or employment of child labour or immoral act or any other violation of human rights or immoral acts, or
    - (v) be holding such fulltime occupation that may not allow the person to give necessary time and attention to the work of the Committee as per the Act and Rules;
    - (vi) be associated with any Child Care Institution, directly or indirectly, during his tenure as a member of the Board or Committee or have any other conflict of interest;
    - (vii) hold any office in any political party during his tenure, or
    - (viii) be insolvent

#### [4]. PROCESS OF SELECTION:

1. All the applications received within the stipulated period in the office of the District Child Protection Unit of the District concerned shall be opened by the District Level Screening Committee having members nominated by the Collector and chaired by the Collector of the District concerned or any other senior officer like ADM / CDO - cum- EO, Zilla Parishad authorised by the Collector, in presence of the applicants or his / her authorised representative.
