Whereas considering the typological error, this office order No.235 dated 12-02-2026 issued earlier regarding delimitation of ward and reservation of seat of **BHANJANAGAR MUNICIPALITY** is hereby revised and the modified order as indicated in Statement-II is hereby issued and in exercise of the power conferred by Sub-sec (3) & (3-A) of Section 12 of the Odisha Municipal Act 1950 (Odisha Act 23 of 1950) read with sub-rule (I) of rule 2-A of the Odisha Municipal (Delimitation of Wards, Reservation of seats and Conduct of Election) Rules, 1994 with notice that the **BHANJANAGAR MUNICIPALITY** in the District of Ganjam shall be divided into **27 (Twenty seven)** wards as specified in column(2) of the Statement-I below with the description and boundaries of the said ward against each in columns (3) & (4) respectively thereof for the purpose of ensuing election of Councilors to the same and the Wards as specified in column (2) of the Statement-II below in which the seats reserved Under Section-11 of the said Act, shall be set assigned against each in column (3) thereof.

Any objection or suggestion which may be received from any person interested in respect of the said Draft Notification on or before the date of expiry of the period of ten days i.e. by **22-02-2026** from the date of publication of this notification will be considered. Objections or suggestions received after the said period shall not be taken into consideration.




