## Section-I

### Instructions to the Bidders

1. The DPMU, Ganjam district requires the services of reputed, well established, financially sound and registered suppliers/ firms for supply of Insulated Ice Boxes of reputed brands under ECRICC Project, Odisha to be supplied to the DPMU, Ganjam for the year 2025-26, 2026-27 & 2027-28.
2. The contract of selected agency/company/firm shall be valid till **28<sup>th</sup> June, 2027**. The period of the contract may be further extended as per the requirement of the client. The DPMU, however, reserves the right to terminate this initial contract at any time after giving 15 days' notice to the agencies.
3. The various important dates relating to the above tender are cited as under:

4. **Mode of Supply:** The Tenderers should note that the bidder shall quote their price per piece for each category (70 Lit & 100 Lit capacity) including **GST & transportation cost** for delivery at **FNGO Pallishree Field Office, At- Belapada, Palur Junction, Block: Ganjam, District: Ganjam and FNGO LIPICA Field Office, Alok Nagar, Ambapua, PO- Engineering School, Berhampur, Pin- 760011**. The selected agency shall supply the items as per the total requirements to be indicated by the DPMU, Ganjam of ECRICC Project for each year (2025-26, 2026-27 & 2027-28). The selected agency /company/firm shall supply the items to DPMU, Ganjam on behalf of the project beneficiaries enlisted by DPMUs on **deposition of 20% of total cost of the Insulated Ice boxes (inclusive of all taxes etc.) by the beneficiary in the bank account of selected supplier agency / company/firm etc)**. The supplier will provide a list of beneficiaries those deposit their contribution at an early date.
5. The payment of remaining 80% of total cost of the Insulated Ice Boxes will be made by DPMU, Ganjam, ECRICC Project to the selected supplier (Agency/Company/ Firm etc.) on behalf of the selected beneficiaries after production of proof/evidence of 20% deposition by the respective selected beneficiary of ECRICC project (bill/ vouchers/bank statement/UPI Snapshot/Cash Deposit slip of the beneficiary) along with acknowledgement for receipt of 20% of cost of insulated ice boxes paid by the beneficiary to the selected supplier.
6. The Tender has been invited under two bid system i.e. ( 1 ) Technical Bid and (2) Financial Bid. The interested agencies/suppliers are advised to submit two separate sealed envelopes super scribing "**Technical Bid**" and "**Financial Bid**" super-scribing

**" Tender Document for supply of Insulated Ice Boxes under ECRICC Project in Ganjam district for the year 2025-26, 2026-27 & 2027-28".**

7. The bidder shall have to deposit the cost of tender paper @ Rs.2000/- (Two Thousand) for participation in the bid in shape of Bank Draft/Banker's Cheque etc. in favour of Divisional Forest Officer, Sambalpur Forest Division. The Tender cost is non-refundable in nature. Cheques will not be accepted.
8. The successful bidder will have to deposit a **Performance Security Deposit** of **3 % of the order value** in the form of Bank Guarantee format at Annexure-1 in favour of **DFO BRAHMAPUR ECRICC GANJAM** drawn in any scheduled commercial bank payable at **HDFC Bank, Brahmapore (HDFC0001107)** covering the total contract period till 28<sup>th</sup> June 2027 plus 12 months. In case, the contract is further extended beyond 28<sup>th</sup> June, 2027, the Bank Guarantee will have to be accordingly renewed by the successful bidder.
9. The Tender paper shall be duly typed or handwritten by ink so as to make it legible and fill in prescribed tender papers. There should be no erasing, overwriting etc. If there are any corrections, those should be made clearly and duly signed by the Tenderer. Tenders are necessarily to be furnished in the prescribed tender paper only otherwise they are liable to be rejected.
10. Rates should be quoted strictly in accordance with the particulars, specifications wherever mentioned in the Tender paper while quoting the rate should mention the specifications, make and brand of the materials, which they can supply.
11. The Tenderer should note that if placed with orders for supply, they will have to supply in strict accordance with the specifications quoted and approved, within the time limit mentioned in the supply order.
12. The above date may be changed as per the requirement of the respective Project DPMU. The items will be supplied as per the supply order to be issued by the DPMUs.
13. The Tenderers should note that the bidder shall quote their price per piece. The agency shall supply the item as per the requirements indicated by the DPMU.
14. The rates quoted shall be inclusive of GST & Transportation Cost up-to FNGO Field Office i.e. **FNGO Pallishree Field Office, At- Belapada, Palur Junction, Block: Ganjam, District: Ganjam and FNGO LIPICA Field Office, Alok Nagar, Ambapua, PO-Engineering School, Berhampur**. Cost shall be determined for a unit of materials/product comprising one 70 lt. insulated ice box and one 100 lt. insulated ice box. The bidder shall propose their financial bid as per the prescribed format. The bidder is not appreciated to adopt self-styled terms & conditions in the Bid.
15. If any Tenderer requires any clarification on the above terms and conditions, he/she may obtain clarifications personally from the undersigned or any Concerned officer of DPMU-ECRICC on any working day during office hours and on that ground no extension of time will be allowed.
16. **Tender Bid Validity: The Bid shall remain valid for a period of 90 working days from**

the last date of submission of tender application.

17. The competent authority of DPMU reserves the right to reject all bids / terminate the tender process without assigning any reason thereof.
18. Joint Venture/ Consortium/ Sub-Contracts are not allowed under this tender process.
19. The conditional bids shall not be considered and will be outrightly rejected in very first instance.
20. In the event of any dispute arising in respect of the clauses of the agreement, the same shall be resolved through negotiation. Alternatively, the dispute shall be referred to the next higher authority or controlling officer for his decision and the same shall be binding on all parties.
21. All disputes shall be under the jurisdiction of the court of respective project districts.
22. **Dispute Resolution:** if the dispute is not resolved at DPMU or higher level, State Project Director, SPMU, ECRICC Project, Bhubaneswar is the final authority for settlement of disputes between DPMUs & the Selected Supplier.
23. In case, the bidders withdraw their bid after opening of the bid shall be debarred from participating for one year in any type of Tender process of DPMUs-ECRICC Project. Related Guidelines of Government of Odisha shall be considered for final decision of DPMUs.
24. Tenders duly filled in the prescribed tender paper shall be sent in sealed cover to the Divisional Forest Officer (T), DPMU, ECRICC Project, At- Courtpeta Square, Kamapali Road, Berhampur, Pin-760004 by name and super scribed "**Supply of Insulated Ice Boxes under ECRICC Project**" at the top left-hand corner of the envelop. The Tender so received up to 5:30 PM of dt. **6<sup>th</sup> March 2026** and will be opened on **7<sup>th</sup> March 2026 at 11:30 AM** in the presence of such tenderers or their accredited representatives in their absence with proper official communication.
25. Bidder to ensure erection of ECRICC logo & Name in the prominent space of the product (Insulated Ice Boxes) within the budget mentioned above before delivery and distribution of the products to the individual beneficiaries for branding and visibility of ECRICC support to the fishers and its impact.

### Eligible Criteria of the Supplier

#### Minimum Eligibility: Technical Requirements

The bidder/ Supplier should fulfill the following technical Qualifications to participate in the Tender process: Absent of the following documents will be treated as non-responsive.

#### Method of selection

- Financial proposals shall be considered for that agencies/supplier who found to be eligible as per the requirements of the technical proposal and final selection of the supplier would be decided by the committee based on the least quoted price among all eligible bidders. The financial proposal should be submitted in the format mentioned in the Bid document.
- The Financial Proposals shall be opened in the presence of the committee members and bidders' representatives who choose to attend.
- The firm shall quote their price against each Insulated Ice box (70lt & 100lt) mentioning the Brand / Company and specification of the product.
- The sample item may be tested if decided by the competent authority. The sample test may be a part of eligibility criteria if urgency arises.
- Mere quoting less price will not entitles any bidders for winning the bid and the Committee has the discretionary prerogatives to finalize the bid with reference to the quality and other technical parameters for the product.


