





PART – I

1. Sealed tenders are invited from **Vendors** for supply and installation as per Appendix-II.
Last date & time: _____ up to 5:00 PM.
Opening date: _____ in presence of the intended suppliers/representatives who may desire to attend (Authorization letter of organization required).
2. Rates must be quoted **in words and figures**, without overwriting, in **Appendix-II**, valid for **6 months**.
3. Detailed specifications, make, model, and **original catalogues** must be enclosed, failing which bids will be rejected.
4. Equipment must strictly confirm to **Appendix-II specifications**.
5. Rates must be **all-inclusive of all taxes, duties, freight, transportation, insurance, installation, and demonstration**.
6. Installation and successful demonstration are **mandatory**.
7. **Envelope No. 1 – Technical Bid** must contain documents (a) to (g).
If any mandatory document is missing, Financial Bid will not be opened.
 - a) Tender Form
 - b) Demand Draft for EMD @ 1% of estimated cost
 - c) Income Tax Returns for last three (3) years
 - d) Audited Financial Statements for last three (3) years
(*Minimum turnover Rs. 25,00,000/- per year*)
 - e) Catalogues/Pamphlets/Pictures with technical specifications
 - f) Part-II of Appendix-I (Undertaking)
8. **Envelope No. 2 – Financial Bid** shall contain only Appendix-II.
9. Both envelopes must be sealed in **Envelope No. 3**.
10. The equipment shall be delivered and installed at **Kanaka Durga PG of Balarampur village of Chatrapur Block, Ganjam (Odisha)**, within one (1) month from the date of issue of the work order.
11. Undersigned will reserve full right to open/consider the second envelop if and only if the Department of Mission Shakti is satisfied with information contents in envelope No.1. The decision of the aforementioned department regarding this will be final and shall be binding on tenderer.
12. The technical Bid will be evaluated first and only after satisfactory qualifying the technical bid, financial bid of the successful bidder will be considered for open.
13. The most responsive bidder in financial bid offering the lowest price (L1) shall be awarded the contract for supply and installation of equipment & machineries for establishment of food & spices unit at the desired location.
14. The supplier will have to supply, in full the articles as per the order till date of validity of rates.
15. The tenderer shall have to deposit Earnest Money Deposit (**E.M.D.**) **1 %** of cost tendered through **Demand Draft (Nationalized Bank only)** payable at Chatrapur in favour of The CDO-Cum-District Mission Shakti Coordinator, Department of Mission Shakti, Ganjam.

16. If the tenderer fails to comply with the supply order within the specified period his order will be cancelled and EMD will be forfeited.
17. The quantity mentioned in Appendix II of this tender is subject to variation according to actual requirement of this office. The quantity may vary in case of competitive market rates, the right to enhance or reduce the quantity of any tendered item(s) and right to accept/reject whole or part of the tender, without assigning any reason, whatsoever, is reserved by the undersigned. The decision of the undersigned shall be final and it shall be binding on the tenderer.
18. On acceptance of the rates as per the approved tender, the supply order will be placed by the CDO-Cum-District Mission Shakti Coordinator, Department of Mission Shakti, Ganjam.
19. As soon as the tenderer delivers the tender in the office of the undersigned, it shall be binding on him and he shall not be able to withdraw or amend the offer.
20. The undersigned reserves the rights to accept or reject higher version of instrument/equipment etc. or any other items under the same terms and conditions and same price quoted by tenderer in Appendix-II.
21. **Payment Schedule:**
 - 70% on delivery
 - 20% on successful installation and demonstration
 - 10% after 3 months or 800 running hours whichever is earlier
22. “Any individual holding membership in more than one agency shall be permitted to apply and participate in the tender process through only one agency. Participation through multiple agencies shall not be allowed.”
